9) Old business

- a) Review of district policies and procedures in fall 2016
 - D. Short reported that the District Instructional Policies and Procedures Subcommittee will be meeting over the summer to work on a number of policies and procedures intended to be approved prior to the accreditation visit. Because of the timeframe, D. Short plans to forward these policies and procedures for concurrent review by the Curriculum Committee and the Academic Senate at the beginning of fall semester.

L. Pink expressed a concern about civility standards in email and other forms of communication, particularly between students and faculty members. He reported that he has placed a course policy in his syllabus about this issue, and as a result the number of uncivil communications has greatly declined. He suggested a review of existing district policy to determine if any updates were needed to address civility in email and other forms of electronic communication. W. Sherman stated that he believes a policy on civil discourse exists in the district and perhaps this would be the appropriate policy to review and/or edit. P. Hopkins reported that a similar item was discussed by the deans some time ago and that it could be potentially addressed as a classroom conduct policy. Committee members continued by discussing the following:

- Hostile communication in person and via email
- Existing district policy on civil discourse
- Existing district policy on email use
- Communications considered private and not private

At the conclusion of the discussion D. Short summarized that the committee suggests a review of existing policy on civil discourse to determine if changes related to electronic communication or other communication channels are needed. P. Christopher noted that if the policy applies to students then it should be noted in the catalog and/or other communication tools accessible to students. M. Sanft agreed to forward a copy of the existing district policy on civil discourse to committee members. L. Pink agreed to forward a copy of his classroom email policy to committee members.

- P. Christopher initiated a conversation about the feasibility of substituting MATH 119 for PSYC 258 in the Economics ADT. Several committee members shared their perspectives.
- M. Sanft and W. Sherman initiated a conversation about the advantages and disadvantages of

submitting MATH 119 to a C-ID descriptor related to sociology statistics. D. Short explained the difference between one-way and two-way articulation. Because C-ID is two-way, it may be disadvantageous to submit MATH 119 for this purpose, because then the district would be obligated to use other courses that meet the sociology statistics descriptor to clear requirements that our MATH 119 course fulfilled; this may not be appropriate for some majors.
