## IV. Reports

## A. Guided Pathways Steering Committee: Student Success Teams - L. Brewster

- Please see the IAST application, which was sent out by A. Gonzalez and will be sent out again by Murphy for all IAST positions. The deadline is Friday, April 4<sup>th</sup>.
- Not just Cohort 1, but also 2 and 3 (open to anyone; find a team; send Brewster questions).
- Adjuncts are welcome to apply and will be compensated.

### B. Diversity and International Education Committee - A. Arancibia

- Will be changing name to Inclusion, Diversity, Equity, and Anti-Racism (IDEA) Committee. Completing paperwork now.
- Still working with Native elders on the land-acknowledgement statement. This will be a process.
- Continuing to work on Ethnic Studies degree.
- Slated to start in the fall of 2021. Members have taken the lead on 2-3 Circle of Change events.
- Many events have been held, as well as upcoming, to push the conversations of diversity and equity further on campus and in the community.

### C. Distance Education Subcommittee - A. Gloag

- Shares the survey results, completed by over 100 faculty. 60-70 different software/platforms were mentioned by faculty as being used throughout our campus. The results of this survey will help inform the committee on what to purchase.
- Committee will also use this to help inform the campus about what is available.

## V. Business: Action Items

- A. Code of Conduct for Academic Senate Meetings J. Alley
  - Item postponed to the next meeting at the request of the presenter.
- B. AS Exec Committee 2021-22 Election: Form Election Committee and Open Nominations L. Murphy
  - Per our Constitution and Bylaws, we need to form an Election Committee for the 2021-22 Executive Committee election.
     Committee Composition: Three Senators, with one to act as Election Committee Chair. M. Woo, C. Gilley and C. Cuz-Flores volunteered, with Woo acting as Chair.
  - Woo officially opens nominations for President-Elect, Treasurer, Secretary, and two At-Large positions.
  - The Elections Committee will work with Bartolomei to send communications, distribute email ballots, and count votes.
     Please send any nominations to Woo and Bartolomei.

## C. Resolution about Elimination of Nonsubstantive Changes - D. Short

 Recent changes to the 7th Ed. of the Program and Course Approval Handbook (PCAH) have eliminated the nonsubstantive change category.

- SDCCD Curriculum Chairs and AS Presidents created Resolution to take to the ASCCC Plenary on April 15<sup>th</sup> to address issue.
- Motion to suspend the rules and approve today passes with no objections. [Carrasquillo/Booth]
- Motion to approve Resolution about Elimination of Nonsubstantive Changes passes with no objections. [Kinsinger/Booth]
- D. College Governance Handbook Final Draft (2<sup>nd</sup> Reading) M. McMahon, S. Lundberg, and S. Young
  - Motion to approve CGH. [Kinsinger/Kjartanson] Discussion ensues.
  - Request made to put DIEC in the parking lot for further discussion down the road.
  - Murphy shares that the Senate's charge at this time is to consider approving the handbook as is. Discussion regarding changes should have occurred at CGC. Murphy clarifies that CGC is not a committee of the AS, it is a participatory governance committee involving all constituencies.
  - McMahon explains that DIEC in the new handbook is under the College Council and has never been in the parking lot. McMahon reports that there was a lot of discussion between CGC, Murphy and DIEC to add input throughout the process. No further input was provided this semester as to the current configuration in the draft CGH. The purpose of the parking lot is for unresolved items, and CGC is unaware of any outstanding issues regarding that committee.
  - Lundburg confirms that the College Council can work on any editing or revisions with DIEC once it is under the College Council.
  - Murphy calls the question and reiterates that the handbook is not set in stone and changes can be made down the line.
     Motion passes with a vote of 15 yays, 10 nays, and no recorded abstentions. Murphy will forward results to CEC.

   Judy Patacsil is new Equity Coordinator.

# B. Implicit Bias Resource Document - L. Murphy

- Review resource document sent in Senator packet for this meeting. Encourage edits, additions and removals to optimize document.
- Could charge the AS Equity Workgroup to provide additional input. Send suggestions to Murphy, who will forward them
  to the workgroup.
- Recommendation made to formalize and approve document as a resource. Recommend additional training using these resources once they're approved.
- Discussion about whether this should required/mandated training or resources. At this point, item will be sent to AS Equity Workgroup, remain as discussion item, and come back to this body for action at a future meeting.

## C. Accreditation Process and Faculty Co-Chair - L. Murphy

- Looking for feedback from body about what involvement faculty want to have in this process.
- Faculty will be compensated for this role, but how much and if adjuncts can apply can be answered by Miramontez, who will be coming to a future meeting to share more details and answer questions.
