## **Security Deposit Remittance Guidelines**

- 1. Unless otherwise noted all labor for repairs and cleaning is \$50 an hour per person plus materials in addition to a \$100 coordination fee.
- 2. <u>Excessive Trash</u> Hourglass Field Community Park and adjacent parking take an average of 10 man-hours to clean after a weekend. Events leaving excessive trash requiring over 12 man-hours of cleaning will be charged. The group will be invoiced for any additional labor over the normal 10 hours.
- 3. <u>Turf</u> Groups will be charged for damage to the turf. The turf is deemed damaged if a bare spot larger than 1' by 1' is noticed.
- 4. <u>Damaged Foliage</u> Groups will be charged for damage to the foliage. The foliage is deemed damaged if people have walked through ground cover creating a dead spot or path. Damage to the foliage also includes broken tree branches, limbs or vines.
- 5. <u>Damage to Hourglass Facilities, District Property, or Equipment</u> An item is considered damaged if an over act caused by the rental disrupts the normal use of or disfigures any property or equipment on the SD Miramar College Campus. Only the San Diego Community College District (SDCCD) may authorize repairs to the facilities.
- 6. <u>Graffiti</u> Graffiti damages are fined at a rate of \$50 per square inch. Please notify the Hourglass College or City staff if graffiti is noticed when your group first arrives at the facility.
- 7. Any out-of-pocket costs for providing additional staffing, as a result of lack of leadership and planning by the renter, will be charged at a rate of time and a half.
- 8. Renderings or vendor related issues will be charged to the user group named on the permit, issued by either the SDCCD or City of San Diego. Health/ (TFF) permits and an insurance addendum listing San Diego Community College District and the City of San Diego are required for all vendors in the amount of two million dollars. Vendors are to also sign and return a liability waiver.
- 9. <u>Gymnasium Floor</u> Groups will be charged for damage to the gym floor. The gym floor is deemed damaged if it is not left in the condition that it was found. A fine of \$500 will be charged to the group for use of tape on the gym floor.
- 10. <u>Bathrooms</u> Groups will be charged for damage to the bathrooms and for missing equipment. The group will be invoiced for the cost of the materials and labor.
- 11. <u>Bleachers</u> Groups will be charged for damage to the bleachers. The group will be invoiced for the cost of the material and labor at time and a half rate. This includes excessive trash, spilled drinks, and damages to the bleachers. Unless authorized on the Civic Center permit groups will be charged \$250 for any person seen on the bleacher during permitted times.
- 12. Storage A fine of \$350 will be charged for unauthorized use and storage not listed on permit of use.
