Consistent with process last year, Technology Committee is dedicating two times this week (October 26 and October 28, 2021) to go through the prioritization of technology related items. Presented today was the unranked excel spreadsheet of 26 technology items (highlighted by school) extracted from the Budget Review Development Subcommittee (BRDS) Request for Funding (RFF) Process, as well as the rubric scoring specified in Tech Plan 3.0. Below is the scoring rubric for ranking RFF's:

This rubric illustrates the general process by which the Technology Committee and support departments will review and rank funding requests. Budget and Resource Development utilizes its own rubrics which are not repeated here. For instance, Safety or Certification issues are dealt with at BRDS.

Technology related items to be ranked are irrespective of cost (this is a BRDS criterion). Comment was made that for Scope of Impact, one possible way is to think about how many students this will be impacting. These would be equipment used for one time/special events versus department impacting greater number of students (refer to student enrollment data from PREDD). Scoring rubric will be used as a general guidance for technology items and will be ranked by each committee member (1 through 26). Updated spreadsheet will be sent and rankings will be entered in column marked (Tech Committee Member Rank". Results will be compiled and discussed in Thursday's

Technology Committee meeting on October 28, 2021, which is an extension of this BRDS RFF technology prioritization meeting. Campus wide notification will be sent accordingly.
