Sanft with the idea of recruiting from the Academic Standards subcommittee. The initiative involves asking colleges to design a plan for adult learners. The first component consists of onboarding while the second portion deals with the awards that the students earn.
- M. Sanft stated she and I. Feldman worked on an Occupational Technical Studies (OTS) award proposal with possible title, required courses, and format changes.

The subcommittee discussed the following points:

 Certain required courses leading to certificates in the workforce areas (Biotechnology, Emergency Medical Technician, Fire Technology, Paralegal Studies, etc.)

- Including the Guided Pathways perspective in order to connect the OTS award to a career/job
- The OTS award allowing students to advance in their current respective career/job
- The OTS award allowing for career exploration; the target audience ranging from high school students to adults unsure of their career direction
- Adding courses that meet requirements in other areas to push for completion
- Possibly placing the OTS award into its own pathway within Guided Pathways
- Incorporating intrusive counseling
- Implicit biases existing in career education
- Connecting with the Career Education department and the School of Business, Technical Careers and Workforce Initiatives dean for their input
