 - 1. A. Stiller-Shulman stated there is a change to Distance Education for Mesa, and an update to the SAM code and the CB23 to CB26 codes.

 - b. How the tutoring courses are funded

- ix. ENGL 216 English Literature II: 1800 Present
 - A. Stiller-Shulman stated ENGL 216 is undergoing a six-year review with a minor Distance Education edit and textbook updates.

 - 1. A. Stiller-Shulman stated the SPAN 202 proposal consists of a Mesa Distance Education revision.
 - 2. The committee discussed the following points:

- a. The Distance Education change from emergency only to hybrid being fine for articulation
- Possibly adding accent marks to the Spanish vocabulary under the Outline of Topics if CurricUNET possesses such a feature
- c. The appropriateness of Student Learning Objective #7, "Analyze common word choices among Spaniards and compare them to those commonly chosen by Spanish speakers throughout other parts of the Spanish speaking world" and Outline of Topics IV. D., "The 'crude' way of Spaniards speaking versus euphemisms used from people in the United States and other Latino-American countries"

- 4. A. Stiller-Shulman will ask the Miramar Spanish department to review the proposal and provide further clarification from the faculty on what "crude" means.

- 1. Vice President of Instruction M. Odu stated Miramar faculty are working on three baccalaureate-level award proposals for Advanced Transportation, Emergency Management, and Paralegal Studies. The Academic Senate in conjunction with the administration will form a team to review the proposals before submitting them for the curriculum process. There is currently no commitment from the State in terms of funding.

Sanft stated AB 928 requires that the three Academic Senates for the California Community Colleges, CSUs, and UCs agree to establish a singular, lower division GE pattern by May 31, 2023. There are currently differences between the UC and CSU patterns. The statewide Academic Senate is seeking input from the public. M. Sanft requested the members and anyone else from Miramar fill out the AB 928 feedback form.
