Facilities Master Plan - (B. Bell, A. Andersen)

B. Bell: The Facilities Master Plan will be going to Board of Trustees, on 5/12/2022.

Reviewed the summary document of what the full document will look like.

Timeline for the plan started last July, and continued with meetings through fall semester.

Shared that there have been meetings in the community, local public service and public safety agencies, and city of San Diego parks and recreation. All have connections or activities that they have participated in, on campus. Discussed the identified demolition and construction plan.

Discussed proposed building:

- Set to be demolished: part of parking lot 3, east part of parking lot 2, I-building and Child Development, K-2 and parking lot A.
- Construction plans for buildings: Existing Lot 3 a new STEM center, additional MBEPS labs, makers lab for BTCWI, and Student Health Services.
- Will retain parking and it will be designed and placed where it will create an entry way.
- West end of campus: Building a performing arts center and English building, where parking lot 2 is. Replace the I-building with a Welcome and multi-cultural center. In front of the complex, will be a gallery.

• This a second representation of what we are calling a Precinct.

Discussed where additional new buildings will be located:

- A new athletic building will be on edge of an existing field; that will not be shared facility with City of San Diego.
- Dedicated spaces for various sports.
- Will have lockers that are more collegiate.
- Multi-level parking structure, will have a rooftop soccer space.

Shared with the architects that Miramar is known for their large amount of parking space and it is critical we do not lose any. Requested the plans to replace parking and future growth of parking. **L. Ascione**: Questioned what would it take to get this achieved. A Bond?

Will no longer call Master Plan. New name will be Miramar Facility Path to 2035.
