Step 1: Apply

- Apply to college at http://apply.sdccd.edu/
 - You will receive your 10-digit student ID # in email from SDCCD within 48 hours
- □ Apply for VA education benefits through VA.gov
- Send DD-214 Member 4 or LES (if Active Duty) with Student ID # to <u>Miramarveterans@sdccd.edu</u> to establish priority registration (for active military and veterans who meet the eligibility criteria)
- □ Apply for Financial Aid (FAFSA) (Optional) studentaid.gov

Step 2: Education Plan

- □ Connect with an academic counselor to set up education plan https://sdmiramar.edu/services/counseling
 - Look for <u>New Student</u> section
 - Online Orientation must be done before meeting with a counselor https://www.go2orientation.com/sdmiramar/sdmiramar

- □ Fill out Semester Worksheet and send to counseling email: <u>miracoun@sdccd.edu</u>
 - Form found on: <u>https://sdmiramar.edu/services/veterans</u>
 - Allow 10 days for processing
 - o A Semester Worksheet is required EACH semester for VA certification
 - Deferment Contract (Ch. 33, Ch.30 and Ch.31 ONLY) is required EACH semester to prevent holds on account
- Once verification is complete, you will receive an email from the Department of Veterans Affairs (DVA) confirming enrollment. (VA 22-1999)
- GI Bill/Ch.33 student will need to verify monthly enrollment with DVA to receive monthly housing allowance
- To prevent overpayment/debt, report any changes such as add/drop/withdraw from classes <u>immediately</u> through a Class Adjustment Form
