

## **ASCCC Site Visit Overview**

As part of its ongoing mission to strengthen and support the local senates of all the California community colleges, the Academic Senate for California Community Colleges (ASCCC) provides opportunities for college visits to provide professional development and technical assistance. To that end, the [Relations with Local Senates \(RwLS\) Committee](#) is working to have all colleges receive a visit from the RwLS Committee and/or the ASCCC Executive Committee at least once every three academic years. The RwLS Committee can provide guidance, support, and resources for local senates and connect you with additional ASCCC expertise as needed.

During spring 2023, in-person and virtual visit availability will be dependent on campus, local, and statewide COVID19 guidelines and ordinances. Please read below for an overview of available visit types. **You may request all visits through the [ASCCC Service Request Form](#).**

### **Local Senate Visit:**

As part of its commitment to supporting local senates, the Academic Senate for California Community Colleges provides opportunities for local senates to have visits from members of the Executive Committee and the Relations with Local Senates Committee. The purpose of such a visit is for the committee member to serve as a liaison between the Senate and the local senate. Our role is to listen to your discussions, share Senate resources to support you, and gather questions and concerns to forward to the Academic Senate President for consideration and response. Support related to the implementation of guided pathways can also be provided. The visit can be with the local senate president, the local executive committee, or the entire senate. (At no cost to the college.)

### **Visit from the Accreditation Resource Team:**

The Accreditation Resource Teams will provide a direct and custom-made response to the needs of local academic senates concerning issues around the 10+1. These teams consider the problem statement developed by the local senate regarding an issue and then create training and potential solution options adapted to the requesting college culture and student populations based upon Academic Senate positions and papers. (Variable cost.)

### **Visit from the Open Educational Resources Initiative Team:**

The ASCCC Open Education Resources Initiative Teams are available to provide support to local academic senates related to OER adoption, curation, development, advocacy, and local implementation. The local senate and OER liaison can request the specific content and format of the visit to meet their college's OER needs. (At no cost to the college.)

### **Curriculum Technical Assistance Visit:**

The Academic Senate for California Community Colleges and the California Community College Chief Instructional Officers have joined together to offer a program of assistance for local colleges and districts. The purpose of the program is to help districts and colleges successfully implement state law and regulations involving curriculum. (\$1,000 fee.)

### **Collegiality in Action Visit:**

The Academic Senate of the California Community Colleges and the Community College League of California have joined together to offer a program of assistance for local colleges and districts. The purpose of the program is to help districts and colleges successfully implement state law and regulations that call for effective participation by faculty, staff, and students in district and college governance. (\$1,000 fee.)
