Context

- A. The **Credit Colleges’** Spring classes started two weeks ago (January 30, 2023) and will end on May 27, 2023. There are **3,963 sections** scheduled (**City**: 1,134; **Mesa**: 1,857, **Miramar**: 972*).
- B. The **College of Continuing Education** Spring classes started two weeks ago (January 30, 2023) and will end on June 10, 2023. There are **899 sections** scheduled.

Summary

Districtwide, there are 45,379 unique students registered for the Spring term.
