
Across the SDCCD in Spring 2022:

4. Land Acknowledgment



"Making a land acknowledgment meaningful"

We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people who have lived in this area for over 10,000 years and honor the past, present, and future stewardship of this land by Kumeyaay peoples.

We acknowledge our occupation of unratified treaty territory and the systemic injustices that occupation of this land has perpetuated for Native peoples of this region. We pay respect to the Indigenous people of San Diego County - past, present, and future - and their continuing presence in their homeland and throughout their historical diaspora.

The Miramar College Academic Senate Executive Committee offers condolences to the family of Tyre Nichols. We support those who want to exercise their right to be heard peacefully. We recognize that our public safety program's values are not reflected in this tragedy. We all mourn with the family of Tyre Nichols and do not tolerate criminal behavior by those sworn to serve and protect us all. We also support creating a safe space for dialogue in our interactions with students throughout our campus community.

7.1 Third Viewing: Meeting Modality for Spring 2023 - Pablo Martin (5 mins., plus 5 mins. for Q&C)

The State of Emergency is scheduled to expire at the end of February.

We can continue to meet virtually through the month until AB 361 sunsets.

Starting in March, the A.S. will need to follow either the traditional Brown Act or AB 2449.

Option 1:

We follow the traditional Brown Act: (in short)

- a. All members can attend meetings remotely (aka via "teleconference").
- b. Folx must list a physical address that they will teleconference from (i.e. their office, their local library, their home, but not their car).

Option 2:

We follow the AB 2449 guidelines: (in short)

- a. 51% of members must be present in person.
- b. Members can miss two meetings a year due to "just cause." More meetings can be missed due to "emergency circumstances."

I would like to entertain a motion to allow the body to vote on their meeting modality preference using a Zoom poll. The option with the most votes will be the modality that the body will follow until the body votes to change it.
