 - a. Sen. Guerra motioned to approve the agenda. Sen. Lester seconded.

 - a. VP Hankinson motioned to approve prior minutes. Sen. Rep Morales seconded.

- F. Public Comment:
 - a. - A. Content Management Update [Kurt Hill] | 15 minutes
 - a. College Council evaluation of internet presence.
 - b. Sen. Guerra moves to revisit this agenda item. Sen. Rep Morales seconded.

III. UNFINISHED BUSINESS

- A. Meeting Modality | 5 minutes
 - a. Vote to extend hybrid modality was discussed.
 - b. After March 31st, State of Emergency will not be extended. Must attend in person with a call-in option for urgent situations.
 - c. Sen. Rep Morales moved disband hybrid modality. Sen. Kuo seconded. Motion approved. Next meeting will be fully in person.
- B. Graduation Stoles [Danish] | 5 minutes
 - a. \$45 w/out design. \$18 for logo, \$5 text \$70 per stole. Looking to purchase 6 stoles. \$600 total estimate. Tre. Danish stated this purchase is within ASG budget.
 - b. Sen. Kuo motioned to allocate \$600 dollars for purchasing stoles. Sen. Hannah seconded. Motion approved.

IV. NEW BUSINESS

- A. ASG Senator Stipend | 10 minutes
 - a. Current senators who file paperwork and attend meetings get a \$50 monthly stipend.
 - b. Miramar College is the only community college that offers senators a stipend out of the sister colleges.
 - c. The constitution states that ASG senators can get a stipend if the advisor sees it financially possible.
 - d. Discussed how senator stipend budget can be allocated for events beneficial for the student body. HEERF funds have been used heavily in ASG events and may not roll over next year.
 - e. Extensive onboarding process has become an issue in administration.
 - f. Vote must be made. If vote is to change senator stipends, constitution must be changed.
 - g. Sen. Kuo motioned to extend the discussion. Sen. Rep Morales seconded.

h. Sen. Guerra motioned that the Constitutional Amendments Workgroup get permission to take over this discussion. Sen. Lester seconded.

B. SSCCC Travel | 10 minutes

- a. Sen. Rep Morales is ASG representative for SSCCC and their 2022 General Assembly is coming up. ASG would have to find an advisor, pay for a travel cost (flights, board, etc.) for both our representative and their advisor. Mesa and City will not be sending delegates.
- b. Assembly is available online. Workshops, etc. are not.
- c. Dean Barnard discussed this funding would come from the advocacy budget.
- d. Sen. Le motioned to extend the discussion by five minutes. Sen. Lester seconded.
- e. Sen. Guerra motioned to send a delegate to SSCCC online. Tre. Danish seconded. Motion passed.

C. Equity Ambassador | 15 minutes

- a. Pres. Borek has been looking into creating an equity ambassador position. An officer in this position would work closely with the equity committee and LEAD office to aid our affinity groups in clubs, events, campus life, representation, etc.
- b. Pres. Borek discussed creating this officer role in the constitution.
- c. Sen. Kuo self-nominated for the position. Sen. Rep Morales seconded. Sen. Caldwell self-nominated for the position. Tre. Danish seconded Both appointed as ASG Equity Ambassador.
