- A. Executive Reports
  - a. President
    - Pres. Allen Kuo attended the United Student Council meeting, where they talked about changes. Student enrollment fees have been changed greatly: there will be an \$18 parking fee for intersession. District wants to hold a general training for all ASGs in the district next semester. Should they do it in September, October, November, or December? Want to hold a leadership summit with UCSD and SDSU, and were wondering if anyone was interested in attending. The Miramar College biotech program is offering three free training sessions. They are holding a meeting from 12:30 to 1:30 PM on Zoom on April 5th. The application is due April 14th. May come with a \$1000 stipend.

Enrollment is 14% up. The employees who were fired for not following the vaccine mandate will return soon, and get their jobs back. They are interested in surveying students on whether 8 week or 16 week classes were preferred. Sam and Malia Kernst are the employees of the year. We received a Native Students Success grant.

In the student lounge, student affairs will be showing a climate change film on April 18th and the Kitchenistas film on April 20th. There will be a vernal pool cleanup on April 21st.

The committee went over counseling issues, and will invite the Vice-President of Student Service Adrian Gonzalez and Dean of Matriculation Allison Douglas-Chicoye to the next meeting to talk about this.
