Governor Newsom Releases May Revision

The <u>Governor's May revision for the 2023-24 budget</u> has brought mixed news for California Community Colleges. On one hand, the revision includes a 8.22 percent costof-living adjustments (COLA), which will help colleges cope with inflation and rising expenses while maintaining record high per-student funding levels. On the other hand, the revision also includes problematic cuts to several one-time funding sources that were proposed in the Governor's Budget in January.

The most notable reductions are:

• A decrease of \$100 million one-time Proposition 98 General Fund for community college efforts and focused strategies to increase student retention rates and enrollment, such as online education, dual enrollment, and guided pathways.

- A decrease of approximately \$345 million one-time Proposition 98 General Fund for the California Community College COVID-19 Recovery Block Grant, which was intended to support colleges in addressing the impacts of the pandemic on students, faculty, and staff. The revised amount for the block grant is \$305 million one-time Proposition 98 General Fund.
- A decrease of around \$239 million one-time Proposition 98 General Fund for deferred maintenance needs, which will affect the ability of colleges to maintain and improve their facilities and infrastructure.

These adjustments reflect revised estimates of available Proposition 98 resources, which are lower than expected due to slower economic recovery and lower tax revenues.

The final budget will be determined by the negotiations between the Governor and the Legislature, which are expected to conclude by June 15. The budget will take effect on July 1, 2023.

Complete the AB 1705 Survey

As the AB 1705 implementation is set to begin soon, the Chancellor's Office is discussing how to measure and ensure equitable placement under the new law, which requires colleges to place most students in transfer-level math and English courses. FACCC opposed this bill because it provides a one-size fits all solution that disregards student agency and doesn't provide sufficient support for faculty to teach a broader range of students.

Results from some local colleges show some concerning outcomes for certain student populations. For example, Las Positas College saw a disproportionate impact in drop data for female, Latinx, first-gen, and older students' direct placement into transferlevel math. Unfortunately, drop data isn't being appropriately collected.

This is why it is so important that FACCC collects stories of students' experiences with direct placement and enrollment into transfer-level math and English courses. To that end, we've created a student survey on this issue, and your responses will help inform our collective work. We encourage faculty to ask students impacted by this legislation

California Higher Education Systems Continue to Feud Over Bachelor's Degree Program

Two California lawmakers, State Senator Josh Newman and Assemblymember Mike Fong, <u>have requested the state's community college system to pause applications</u> for new bachelor's degree programs.

The state has allowed community colleges to offer bachelor's degrees since 2017, and the program was <u>expanded in 2021</u>. However, the expansion comes with a caveat that community colleges cannot offer a four-year program already provided by the California State University or the University of California systems.

Critics of the program are concerned it will hurt enrollment at the four-year institutions, while supporters argue that it would help address workforce shortages and provide opportunities to those who wouldn't otherwise attain four-year degrees.

The lawmakers' request <u>came after pressure from the Cal State system</u>. A working group has been formed to address the issue, including representatives from the California Community Colleges system, the Cal State and University of California systems, and the Association of Independent California Colleges and Universities.
