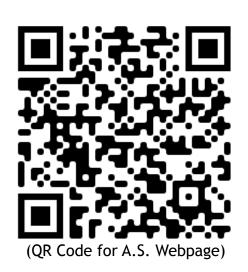

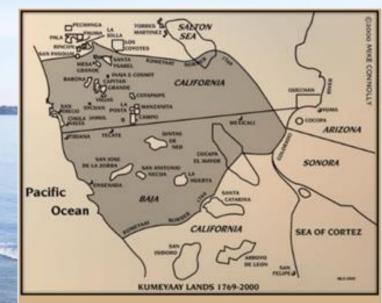

# 3. Land Acknowledgment

We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people, who have lived in this area for well over 10,000 years, and we honor their past, present, and future connection to this land and its inherent connection to their identity.

We acknowledge our occupation of unceded Kumeyaay land and the violent systemic injustices this has continuously perpetuated for Native peoples of this region. We pay respect to the Indigenous people of San Diego County - past, present, and future - and honor their continuing presence in their homeland and their spiritual beliefs that land does not belong to people; people belong to land.

We also acknowledge that this is merely the beginning, and there is far more work to be done in an attempt to heal all of the injustices and inequities that still exist today and throughout their entire historical diaspora. Hopefully we can find a way to move forward together.



#### **KUMEYAAY MAP**

The above Mike Connolly historical "Kumeyany Lands 1769-2000" map picture details the 2005 Indigenous California Indian tribes of the greater Southern California area and northern Baja California, Mexico, the Native American Indian reservations, and contrasts them with the Indigenous Kumeyaay territory of 1769 (gray area).

  - Miramar Resolution Supporting Reassign Time Faculty Equity Coordinators
  - This is a first read—the body will be asked if they support this action at the next A.S. meeting

- 6.3. Reducing A.S. President Reassignment to Support Professional Advancement Chair Pablo Martin (5 mins. plus 5 mins. Q&C)
  - AFT's recommendation for 2.0 allotment includes a .2 reassignment for the Chair of the Professional Advancement Committee
  - This is a first read—the body will be asked if they support this action at the next A.S. meeting

- 6.4. Meeting Modality Recommendations for A.S. Committees Pablo Martin (5 mins. plus 5 mins. Q&C)
  - This is a first call—if the body arrives at a recommendation, they will be asked to support it at a future A.S. meeting (after a first call)
  - All meetings, Brown Act and otherwise, have the option of meeting via "teleconference" (aka Zoom), albeit with different requirements
  - Given the flexibility we have enjoyed at the A.S., the Exec would like to explore making a recommendation to our Standing Committees to provide similar accommodations to their members

- 6.5. Technology Discussion Technology Committee Representatives (5 mins. plus 10 mins. Q&C)
  - Despite some concerns, the committee will explore hybrid meetings
  - HyFlex Update -- by the start of next semester, the following areas will be HyFlex capable: K1-202, K1-107, H-205, A-223, and M-110
    - Spaces not currently in use may be available sooner than that
    - Access will likely be managed by individual schools/departments
    - Miramar's Technology Department will provide training
    - The <u>REC Innovation Lab</u> also has a HyFlex space for students and their instructors/mentors; interested students and faculty are invited to visit and learn more on Thursdays after 4:00 PM

- 6.5. Technology Discussion Technology Committee Representatives (5 mins. plus 10 mins. Q&C)
  - Technology Plan: the current plan was approved by College Council October, 2021; it has not been revisited/updated since 2020
    - The T.C.'s goal is to align this plan with the newest ACCJC Standards (which will come out soon)
    - The two different approaches to technology planning will be shared
    - All technology resource requests must be in Program Review
    - Professional development needs, as well as communication about services, software, etc. may also be addressed

- 6.5. Technology Discussion Technology Committee Representatives (5 mins. plus 10 mins. Q&C)
  - How can communicating with Academic Senate benefit the T.C.?
    - The T.C. is addressing the <u>faculty concerns</u> brought to President Lundburg and Associate Vice Chancellor of Information Technology Services, Peter Maharaj in May 2023
    - The T.C. will provide <u>regular updates regarding steps being taken</u> to resolve those concerns at Senate
    - Do faculty have other ideas for ways the Senate can work with the T.C. to address these and other concerns?

#### **Campus/Senate Updates:**

1. Hearing folx's concerns around class cancellations and potential impacts to programs, the A.S. Exec will recommend that the Enrollment Management Committee create a workgroup to assess and explore the process for cancelling low enrolled classes and provide recommendations to the College on how to best follow the process outlined in the CBA

- 6. Two new faculty, professional development opportunities were just announced: Credit for Prior Learning Coordinator and Military Education Lead. Please see the emails from Carol Sampaga in the VPI's office.
- 7. Updates from College Council (link to the <u>recording</u>, link to the <u>agenda</u>)
  - President: anticipate changes to the Campus Allocation Model (CAM) based on the Student-Centered Funding Formula (SCFF); awarded \$250k from the Conrad Prebys Foundation to reimburse students for licensure fees (allocation method TBD); we are applying for the second round of funding for \$250k to support student basic needs; SDCCD is negotiating with a lease organization to provide all food services on campus
  - Classified Senate: bylaws review meeting on 10/5; put call out to fill VP and Senator-at-Large

  - Associated Student Government: Acting Chancellor Smith attended recent ASG meeting and discussed affordable housing project, budget, student emails, food services, and OER/ZTC; working on appointing students to committees; planning for Fall Fest is underway

  - The Strategic Enrollment Management plan was approved with recommended edits for clarity and accessibility of information.
  - Vote on the Graphics Program Discontinuance recommendation will take place on October 10<sup>th</sup>.
  - Leadership is still looking for input on ways to promote this year's theme.

- As part of the regular six-year cycle, the Board of Trustees is reviewing changes and updates to a number of Board Policies. The other A.S.
   Presidents and I saw nothing of concern here with two exceptions:
  - Possible concern over changes to the time allotted for public comment. The AFT's reps are leading the discussion, but please let me know if you have any input to share.
  - All four A.S. Presidents are meeting with the Acting Vice Chancellor of People, Culture, and Technology Services Office of People to revise and update AP 7211 (Faculty Service Areas, Minimum Qualifications, & Equivalencies.) The first meeting was very productive and we hope to have an updated AP for you at our next A.S. meeting.
