

3. Land Acknowledgment

We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people, who have lived in this area for well over 10,000 years, and we honor their past, present, and future connection to this land and its inherent connection to their identity.


OER (Open Educational Resources)

- Planning ZTC Tracking Dashboard
- Round 1 Funding of \$60,000 from credit colleges

 - Assist faculty developing ZTC courses
- Textbook Transparency Updates
 - Low textbook cost being created
 - Planning addition of College of Continuing Educatio



Community Funding Grant

- Created and onboarded new Community Funding Grant Faculty Coordinator
- Onboarded new OER Specialist
- Round 1 funded 16 applicants (examples of projects)
 - BIOL 107: Biology Professor Sarah Hawkins remixed an OpenStax text and other openly licensed videos into her CVC-OEI aligned Canvas course, including interactive formative assessments using H5P.
 - AGRI 100: Agriculture Professors Erin McConnell and Abigail Ferrieri also remixed existing OER text into a Canvas course, adding in their own videos as support.
 - FREN 101: French Professor Philippe Patto created an entire interactive French 101 textbook using Pressbooks with interactive elements using H5P and examples of spoken French with accents from different regions using Voicemaker.

- 2022/2023 FLOC OER program. 40 faculty learned about OER and how to search, adapt, or create OER for their courses in collaboration with mentors and peers.
- 12 math faculty trained in using MyOpenMath in 2022-2023. Over 60% of our math sections are ZTC.



- At least 3 faculty members working on ASCCC OERI grant funded projects.
- Offered 5 Flex presentations on OER and ZTC + 1 for OpenEd week. Have 3 more Flex presentations planned for Fall.
- Applied for & accepted to AAC&U OER Institute. Received \$6200 scholarship from ASCCC.
- OER Librarian enrolled in Creative Commons Certificate for Open Culture/GLAM (galleries, libraries, archives and museums) for Summer. Received \$300 scholarship.

SAN DIEGO COLLEGE OF CONTINUING EDUCATION

- CE's ICOM Academy which offers certificate programs and uses 100% OER/ZTC materials, has more than doubled its course offerings since last Spring. There were 48 ICOM classes offered during the Fall 2022 semester and 54 ICOM classes offered during the Spring 2023 semester.
- CE's book loaning program out of the Office of Instructional Services has continued to serve students for the hard to convert (H2C) programs, Hyflex classes, and students learning online.
- Fall 2022 savings examples include:
 - Students in all ICOM sections were provided digital OER/ZTC materials with a savings of over \$4,500
 - Students in HLTH, AUTO, and ESLA sections were provided loaner or OER materials which was a savings of over \$20,000
- OER Coordinator, Diana Vera-Alba created an OER/ZTC Canvas account that was shared with SDCCD and contains OER resources which include: OER/ZTC materials, Creative Commons licensing, training and PD.
- Every year the CE ESL Textbook

<u>Committee</u> promotes the <u>Bachman Jennings Book Fund</u> which has raised over \$15,000 year-to-date and distributes book vouchers to students.

BIT Team Function at Miramar

- The Behavioral Intervention Team is an interdisciplinary team that meets on a regular basis to review and respond to reports of student behaviors that are concerning and at the present time do not meet the criteria for a student conduct violation, an emergency situation, a perceived or present threat, imminent danger including self-harm or a threat to the community (which should be reported to College Police or 911).
- Provides a safe environment for the campus community to report student behaviors of concern through collaboration, information collection, risk assessment, and intervention
- Promotes campus safety
- Supports students via educational and supportive measures
- Provides consultation, referral, and support to faculty and staff

Appropriate Referrals for the BIT

- Non-immediate thoughts/ threats to harm self or others
- Unaccountable change from good to poor participation in services
- Regularly missing appointments or arriving late
- Change in pattern of interaction
- Marked change in mood, motor activity, or speech
- Marked change in physical appearance
- New or regularly occurring behavior which pushes the limits and may interfering with program services
- Unusual or exaggerated emotional responses
- Food or housing insecurity affecting daily functioning

Please Note: Basic needs concerns, mental health challenges, disability support needs etc. on their own may not be a referral to BIT, but a referral to an individual service.

When in Doubt, Reach Out

911 Emergencies-Not a BIT Referral

- Imminent threat to safety of others
- Threat of harm to self or others
- Incoherent or delusional speech and/or behavior

What happens after a BIT form is submitted?

- The BIT chair completes an initial review of the reported concerns
- The reporter receives confirmation of their submission
- Depending on the nature and urgency of the referral, the chair may respond immediately or await discussion at the next BIT meeting
- BIT response may involve one or multiple team members
- When needed the reporter is contacted for additional context
- The student of concern is often contacted and provided with supportive resources
- Due to student privacy, specific actions taken may not be available to the individual who filed the report

- 6.3. Final Recommendations from the Packaged Programs Workgroup -Pablo Martin (5 mins. plus 5 mins. Q&C)
 - See the complete document here
 - The workgroup was assembled in Spring 2023 under the direction of the Academic Senate and the College Council.
 - The document includes five sections: 1) The benefits of offering packaged programs (PPs); 2) The disadvantages of offering PPs; 3) Recommendations; 4) Other considerations; and 5) Information and concerns related to existing packaged programs.
 - At College Council on 10/24, I asked the VPs to share this with their Deans and Chairs so they might explore programs that might benefit

- 6.3. Final Recommendations from the Packaged Programs Workgroup (cont.) - Major recommendations include:
 - Identify two "tracks" or approaches: 1) packaged programs (all courses required are 8-weeks long) and 2) 8-week courses (identifying courses within programs that can be compressed)
 - Counselors and Success Coaches should be well educated about PPs and 8-week courses so they can either encourage or discourage participation in these accelerated programs based on the best fit for them (noting that implicit biases and institutional racism/sexism etc. would need to be effectively managed)
 - Students should be thoroughly onboarded before the start of the program or course so they are properly prepared and aware of expectations

- 6.4. Technology Discussion Technology Committee Representatives (5 mins. plus 5 mins. Q&C)
 - Wi-Fi Update:
 - No word on the exact date and new login process, but we hope to have that info from the District soon. The rollout of the new system is expected to begin in December and January.
 - Computer Rolldown Process:
 - Kurt Hill is concerned that there is a focus on the age of the computers rather than the performance
 - Faculty on the T.C. argue they are focused on performance, discussing the need for better communication about computer updates and their impact on performance.

6.5. Seeking A.S. Support for Expansion to Gym Access – Hudson Betts, Miramar College Delegate (5 mins. plus 5 mins. Q&C)

Abstract


- Currently, the Miramar College Fitness Center can only be used by studentathletes, and students who take gym courses, allowing them to use the gym once or twice a week.
- This is an institutional barrier to students who are passionate about taking care of their physical and mental health.



Cultivating Community: Making the Invisible, Visible

- Expanding the Miramar College fitness center will provide students who are financially struggling with an affordable gym membership
 - Gyms outside of campus such as LA
 Fitness and 24-hour Fitness, could
 cost more than \$400 a year
- Many first-generation, low-income students can't afford to purchase a gym membership.
- Students shouldn't have to sacrifice their health for financial difficulties





Improving Student Life

- Providing public access can promote a culture of health and well-being, encouraging both students and employees to engage in regular physical exercise
- Working out could help students reduce stress and anxiety from school, promoting overall mental and physical health
- College gyms also serve as social spaces where students can connect with their peers, build friendships, and develop a sense of community
- Study shows that students/employees who incorporate physical exercise into their lifestyle are more healthy and successful.

Making Student Life Better

- Providing a college-wide gym system will encourage students/employees who utilize the fitness center to participate in campus-wide events, overall improving campus engagement.
- Expanding the usage fitness center will result in more students on campus, we will be able to restore pre-pandemic college engagement.
- This idea will be represented through all constituency groups.
 - ASG unanimously approved the idea

I did not see any 10+1 related issues with the redaction of applicant and university names. (My understanding is that nothing else, including CVs, are being eliminated from the screening process.) I have passed a list of faculty concerns along to Wes. I will discuss this with our VP, the Chair of Chairs, and others and report back to the body as this develops.
- 2. The CGH Change Taskforce met and approved a number of minor changes to the CGH. I just received the <u>final summary document for the CGH</u> <u>Change requests for Fall 2023</u> today. Please let me or a member of Exec know if you have questions or concerns. We will add this as a report to our 12/5 agenda unless folx would like to discuss it.
