III. PRESENTATIONS

- A. EOPS Offered Services [EOPS] | 15 Minutes
 - a. Senator Brian motions to table this item until needed, Senator Kayla seconds the motion
 - b. EOPS focuses on providing consistent and frequent counseling for students with the main focus on students who are part of underrepresented groups, Many benefits and services including priority registration and counselors that can provide resources not only academically but for covering basic needs as well
 - c. Senator Kayla asks about if counseling is a one on one, EOPS Representatives explain that there are 3 mandatory counseling sessions with the first two being one on one and the last one being a workshop BUT 3 is the minimum not maximum
 - d. Senator Aiden motions to extend the discussion by 5 minutes, Senator Brian seconds the motion
 - e. Senator Tohni asks about the eligibility, EOPS Representatives respond that you must be a California Resident
 - f. Treasurer Akili asks if you will be walked through reasons you are not accepted, EOPS Presenter says that one of the main reasons for turn away are having over 70 units and already having a bachelor degree
 - g. Vice President Saigel asks what EOPS counts as a first generation student, EOPS Presenter explains that in order to quality the parents of the student would not have a bachelor's degree

 - a. Wellness Wednesday coming up on 11/22, 90 minutes Suicide Prevention Workshop
 - b. Free Headspace Account tied to Student Emails Meditation application for stress management, anxiety, sleep help, etc.

IV. UNFINISHED BUSINESS

A. CALGETC Updates [Curriculum Committee] | 15 Minutes

- a. Replacing the class pathway to general CALGETC for all community colleges in California rather than each school having their own pathway (for example, Miramar's IGETC)
- b. Senator Kayla and Victoria mention that classes taken outside of major prep could affect gpa and subsequent transfer
- c. Senator Sindhu and Computer Science Club mentions that this could be a second chance for many students
- d. Latinx Con Voces mentions maybe providing a tutoring program geared towards those students that need to raise their gpa above a 2.0 in order to receive their Associates Degree
- e. Vice President Saigel asks if grade removal from extraneous situations has been discussed in the CALGETC Committee, Dean Barnard explains that excused withdrawals are in a different category despite both affecting GPAs
- f. Treasurer Akili mentions that UCs already have Major GPAs and General GPAs, so the Curriculum Committee is just looking to bring that to the Community Colleges

- A. Public Art Draft [Facilities Committee] | 15 Minutes
 - a. Senator Brian hands out a draft of the Public Art Guidelines and asks for feedback from the ASG
 - b. Vice President Saigel asks where the Public Art would be applicable, Senator Danna says that they are still collecting opinions but mainly looking towards public areas that people pass by
 - c. Dean Barnard explains that the campus does not appear very welcoming from the lack of murals and forming a school wide policy will give an opportunity for the suggested art to undergo review
 - d. Treasurer Akili motions on behalf of ASG to support the Facilities Committee going forward with the current plan for Public Art, Senator Joseph seconds the motion
 - e. If people have a strong interest in being a part of what happens with Public Art, students should seek attending the next Facilities Committee

 - gives transgender students who face anxiousness when choosing a bathroom a safe place, prevents health problems that students may run into from avoiding using public restrooms, also gives students with disabilities an inclusive restroom, single stall and inclusive bathrooms are on campus but gendered single stall bathrooms are often locked for being in use for different means for long periods of times, non ADA compliant pool bathroom
 - second floor one multi-stall gender abt, I-building gender inclusive restroom

 - c. Senator Brian motions on behalf of ASG to support the plan to include a multi stalled all gender bathroom in the Kaleidoscope, Secretary Yurika seconds the motion
