#### III. PRESENTATIONS

- A. Campus Master Plan Presentation [Vice President Brett Bell] | 30 minutes
  - a. Facilities Path to start 2025 Planning document for what Miramar College will be doing with its facilities by 2035
    - If anybody wants to look at the document, it is available on the Miramar Website under Facilities
    - Looking at which buildings need repair and/or demolition, looking to add 3 new/renovated gathering spaces for students outdoors, changing the entry points on campus, have more unity across the north and south parts on campus, moving the current student services building and replacing the area with an open meeting area, Replacing parking lot 2 with performing arts center and english building, Replacing parking lot 3 with STEM center, creating a new multi-level parking garage near the athletics buildings
    - Short term plan for adding seating outside the library
    - Senator Brian expresses concern with the stones in compass point and if
      people will want to spend time on uneven surfaces, Vice President Bell
      says that the plan is only an outline and will be discussed further at a later
      time
    - President Namod asks if students can expect new seating by the Spring semester, Vice President Bell says that he has found examples of ideal seating at Cuyamaca College and has ordered it but is unsure when it will arrive
    - Computer Science Club Representative asks if there is a plan for extending hours for the cafeteria and the opening of the Treetop cafe, Vice President says yes there is a plan (not enough time to discuss it)
    - Latinx Con Voces Representative asks if there will be an increased amount of outlets, Dean Barnard explains that there is an upcoming presentation about that topic

- Senator Brian asks where student feedback should be given on the program, Vice President Bell explains that through the Facilities committee the student representative can bring up concerns for themselves and on behalf of the ASG
