#### IV. UNFINISHED BUSINESS

- A. Student Rights Cards [Hieu Le] | 10 Minutes
  - a. Business cards that have the ASG Logo along with the SSCCC Logo on the front, and list the 10+1 student rights on the back
    - 10 rights students have under Ed Code Schoolwide decisions shouldn't be made without student input
  - b. Asking the ASG for \$110 in order to supply 500 cards in math lab and other offices
  - c. Dean Barnard suggests putting a contact for ASG
  - d. Senator Kayla suggests outputting a message of "students interested should join ASG", Dean Barnard responds that the logos could be made smaller to include that
  - e. Senator Zach expresses that students on campus would not know when these rights are exercised, Dean Barnard suggests that this could be further looked at next semester as another senator project
  - f. Dean Barnard clarifies that the SSCCC logo does not have to be on the front, as they do not own these rights but rather they are under the California's Community Colleges; unless these cards are being taken from the SSCCC cards, no need to credit the SSCCC
  - g. Senator Zachary suggests that the SSCCC logo should be removed and the ASG information should be included
  - h. Guest says that business cards are likely would be put into the trash, while if they were made into posters people would be able to access that information while not wasting resources
  - i. Senator Kayla motions to extend the discussion by 5 minutes, Senator Zachary seconds the motion
  - j. President Namod asks what the grading policies are (one of the rights), Dean Barnard explains that it could explain how people get extensions, withdraw from classes, anything associated with ho grades are given to students; stops faculty from doing

- whatever they want
- k. Senator Victoria says that this is a great idea but more information on how to get involved in ASG needs to be included
- 1. Senator Joonseo suggests putting a LinkTree including the ASG instagram, discord, website, etc.
- m. Senator Zach motions to move this topic to Governance to figure out the logistic, Senator Kayla motions
- n. Motion passes with majority approval

  - a. Senator Zachary motions to table this topic until after the Governance committee meets, Senator Hieu seconds the motion

  - d. Advisor Caitlyn expresses that there is Jet Jump Start before the semester even starts, Dean Barnard clarifies that there is not necessarily a tour but it may be a good idea for the Student Services K building to have an building-wide open house during the first week of classes
  - e. Senator Zachary asks what kind of games would be included in the open house, Senator Victoria says that in her experience there have been short games with a small prize, even a kahoot, a participatory sticky note wall, stamps, etc.
  - f. Senator Victoria says that if this were to be kept in the Student Life and Wellness committee, there should be a collaboration with the Future Events committee as well
  - g. Senator Kayla motions to move this topic to the Student Life and Wellness Committee, Senator Tohni seconds the motion
