

## 3. Land Acknowledgment

We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people, who have lived in this area for well over 10,000 years, and we honor their past, present, and future connection to this land and its inherent connection to their identity.

We acknowledge our occupation of unceded Kumeyaay land and the violent systemic injustices this has continuously perpetuated for Native peoples of this region. We pay respect to the Indigenous people of San Diego County - past, present, and future - and honor their continuing presence in their homeland and their spiritual beliefs that land does not belong to people; people belong to land.

We also acknowledge that this is merely the beginning, and there is far more work to be done in an attempt to heal all of the injustices and inequities that still exist today and throughout their entire historical diaspora. Hopefully we can find a way to move forward together.







## 6.3. Resolution: The Hiring of General Counselors - Kevin Gallagher (5 mins. + 5 mins. Q&C)


The Hiring of General Counselors Outside of the General Counseling Dept.

- Whereas new General Counseling Faculty not only require proper training to meet the professional standards of the profession; their evaluation process requires periodic observation and feedback by subject matter experts.
- Whereas programs submit funding proposals that often include the need to provide General Counseling services without informing the General Counseling Chair, and General Counselors are furthermore being hired outside of the General Counseling Department (reporting to a Different Dean).
- Whereas General Counselors hired outside of the General Counseling Department are not going through General Counseling's training nor evaluation process, nor will their Priority of Assignment (POA) be established in General Counseling.

#### 6.3. Resolution: The Hiring of General Counselors (cont.)

- Whereas the Academic Senate of San Diego City College has approved a similar proposal.
- Resolved, General Counselor positions needed by programs outside of General Counseling shall be selected from the General Counseling Department whenever possible.
- Resolved, if a new General Counselor must be hired outside of the General Counseling Department, the General Counseling Chair (or designee) shall be included in that hiring process.
- Resolved, General Counselors hired outside of the General Counseling Department shall go through General Counseling's training, and their evaluation process shall include the General Counseling Chair (or designee).

#### **Amendments and Bylaws Committee**

This committee will study and recommend all amendments to this Constitution and its Bylaws. This committee shall consist of the Executive Committee, excluding the President and the Chair of Chairs, and shall be chaired by the Vice President or President-Elect. This committee may opt to utilize the President or a legal or administrative advisor as needed but retains sole authority for any recommendations to amend this Constitution and its Bylaws.

# Report cont.:Amendments and Bylaws Committee

**Proposed Changes to Bylaws:** 

1. Clarify Election Procedures:

#### Article IV.2.C.

If, at the end of the nomination period, there are no nominees for an open Executive position, that election will not be held. Instead, the position, with the exception of Academic Senate President, will be filled within two weeks by Academic Senate Executive Committee appointment. If, at the end of the nomination period, there are no nominees for Academic Senate President, a special election will be held before the end of the semester.

# Report cont.:Amendments and Bylaws Committee

#### **Proposed Changes to Constitution:**

1. Clarify Senate Forum language.

#### Article VIII.1.4.

Senate Forum Committee: This committee is a committee of the whole membership convened by the Academic Senate President to serve as an open forum for any staff, faculty or administrator of Miramar College or San Diego Community College District to advance cultural and community issues. If a quorum of Senators is present, official business of the Academic Senate can be conducted as long as Brown Act requirements were satisfied.

# Report cont.:Amendments and Bylaws Committee

#### **Proposed Changes to Constitution:**

2. Add the new Adjunct Success, Retention and Equity Committee:

#### Article VIII.1.7.

This committee of the Academic Senate shall evaluate initiatives, practices and policies that may have a disproportionate impact on adjunct faculty; increase awareness of opportunities to support adjunct faculty success; identify any disparity in adjunct faculty access to professional development; and explore partnerships to help improve resources and compensation available to adjunct faculty.
