- A. ASG Resolution | 10 minutes
 - a. Senator Zach explains that members of the Mesa ASG approached him asking for support going against the statewide bill that would remove the lower level math courses (Trigonometry, Precalculus), Vice President Sindhu says that she heard that this was a bill that would allow students to skip the course even after placements tests rather than getting rid of the courses themselves, Dean Barnard says that the students choose which math course they want to take and therefore the enrollment for the lower level courses is probably low therefore the schools may be trying to get rid of the courses that no students are taking, President Saigel says that the downside of removing the class would be that students wouldn't have the opportunity to take it
 - b. President Saigel suggests that the ASG gets in contact with the Curriculum committee or Professor Gloag
