Item

1) New Student Success Committee update

Committee members were thanked for their continued service for the 2023-2024 cycle. As this is the final meeting for the committee before it is disbanded, all were encouraged to participate in the new Student Success Committee.

The three committees that are merged to create the new Student Success Committee are Student Services, Guided Pathways Steering and Success Across the Curriculum Committees with an additional influence of the former Basic Skill committee. The membership is robust in order to have adequate representation from the broader campus. The main focus is to collectively support the development and institutionalization of integrated and comprehensive approaches to student success. The committee will primary serve as a "steering committee" and will have workgroups to support the efforts and complete the work, such as, but not limited to ACPs efforts and retention. The first year of the committee will be a "work in progress" and may be adjusted if needed. If interested in participating, contact constituent leaders. Gonzales – Basic Needs Advisory team membership has been identified. The group will meet twice per semester and convene for the first time later this month.

Jimenez – shared we currently have 158 students signed up to graduate. Registration has been extended to 5/3. There are 20 students graduating with a 4.0 GPA.

Douglas-Chicoye – mentioned she would like to explore the option of creating a Transfer Center Advisory group.

Barnard – Basic needs will start a pro-active educational aspect next fall. Today the first session was held, was well attended.

Osuna – reminder May is Foster Care Awareness month. On Wednesday, May 15th the NextUp team is hosting a professional development opportunity from 12:30-1:30pm via zoom.

V. Other

Gonzales shared some of the recent updates on Title IX regulations. There is now additional language to protect LGBTQ+ and pregnant students. Under the new regulation, students, employees and third parties are now permitted to file a complaint. The new definition of a complaint, replaces formal complaint definition with the more broadly defined "complaint" to include an oral request and does not require a signature or otherwise indicate who the person is filing the formal complaint. Additionally, it requires that schools assume an accused student is innocent at the outset of an investigation. When fielding these types of complaints, suggestion is to provide the student with the possible resources and tell your supervisor about the situation. Cheryl Barnard is our campus Title IX officer, contact if need support or have any questions. District support is provided by Amber Eckert.

Fall Jets Jump Start and Convocation will be on Thursday, August 15th from 9:00 -2:30p.m. Convocation will be in the morning, followed by JJS. There will be a focus on ACPs and Community Building.

Ngo shared some updates about Financial Aid. Workshops providing student guidance on FAFSA are continuously offered. Due to some challenges with the newly launched FAFSA form, student information should be packaged approximately by mid-June. The deadline for students to submit their CSAC Cal Grant deadline has been extended to May 2, 2024.
