- a. This segment of the meeting is reserved for persons desiring to address the San Diego Miramar College Associated Student Government (ASG) on any matter of concern that is not stated on the agenda.
- Senator Dnaiel gave a motivational pep talk for this year.
  - Dr. Dean Barnard mentioned the parliamentary procedure, and that Joseph would provide ~20 min. training for new senators. Visitors can only participate in the discussion, they cannot participate in motions or votes to approve/not support the business item.

**V. NEW BUSINESS**

- A. ASG Goals | 15 minutes

- a. Pres. Hailey Hua described that, like last year, we hope to continue (1) low costs textbooks and opened educational resources (2) expanding Basic Needs services & opportunities (3) student engagement, including outreach (4) voter registration
- b. Pres. Hailey Hua opened up the floor for discussion.

- B. [Budget Creation & Approval](#) | 15 minutes

- a. VP Claudio Nevells motioned to table this item for next week. Sec. Kylee Guiriba seconded.
- b. Treas. Sindhu Narasimha motioned to bring this item back on today's agenda. Sen.

Daniel Sifuentes seconded.

- Vote: Majority voted in favor; Sen. Claudio Nevells said “Nay.”
  - c. Treas. Sindhu Narasimha described the budget from last year: we have ~\$25k.
    - Vending 5000 has \$300
    - ASG General Funds are divided into different subsections.
    - Future Event \$11,500
    - Student Life \$5,500
    - Governance \$1,500
  - d. Asked to create a section allocating for Scholarships; allocating \$500 from a committee to fund this section.
    - Dean Barnard - the more we contribute to these Scholarships, the less we have to spend on events for student engagement.
  - e. Sen. Claudio Nevells motioned to approve the 2024-2025 school year Budget Sindhu Narasimha presented, Sen. Daniel Sifuentes seconded.
    - Vote: No one said “I”; Majority said “Nay” → motion dies.
    - Sen. Claudio Nevells motioned to amend the budget so we can include the amount for Scholarships IF the committees choose to include it in their allocations.
    - Treas. Sindhu Narasimha motioned to approve the amendments to the budget. Sen. Frankco seconded.
      - Vote: Majority said “I”; Sen. Claudio Nevells said “Nay.”
  - f. A senator project could be to work with the College Foundation in hopes for them to increase their endeavors for this budget.
  - g. Sen. Frankco motioned to extend the discussion for this business item for 5 mins. Sen. Claudio Nevells seconded.
- C. Voting for funds for the CCCSAA Conference in LA (10/11-10/13) | 5 minutes
- a. Dean Barnard - California Community College Student Affairs Association Conference.
    - Professional development for staff and student leadership conference held where 177 community college student reps participate in leadership workshops and meetings.
    - In the past, we usually vote to send 8 people: 4 members and 2 advisors and will be going in a van together.
    - Cost ~\$11k.
    - Need to have paid the \$8 AS Membership on SDCCD portal; for student rep. +\$2 → any advocacy endeavors.
  - b. Joseph Hankinson - for 7 people, ~\$7339.
    - Suggested to bring 10 people & 2 advisors (Joseph Hankinson or Dean Barnard & Sandra Marquez) → \$10k, but recommended to increase budget up to \$12k (WITHOUT hotel tax); need to stay at the Biltmore Hotel.
    - The purpose of this budget would be to ensure we have enough to bring 10 students covering their meals, stay at the hotel.
  - c. Sen. Claudio Nevells motioned to approve the budget up to \$12k. Sen. Daniel Sifuentes seconded.
  - d. VP X. motioned to increase this item for 5 mins. Sen. Daniel Sifuentes seconded.
  - e. Pres. Hailey initiated a vote for the approval of the budget:
    - Majority of the party said “I.”
    - Sen. Claudio Nevells said “Nay.”
- D. Special Elections (9/6) | 5 minutes
- a. Apps. due next Friday (8/30) to the Student Affairs Office to Sandra Marquez.
  - b. Recommended to get 30 signatures instead of the minimum of 25.

- c. Joseph Hankinson - Suggested to those interested: be present on the day of elections, prepared to introduce yourself and why you want to be a part of ASG.
- d. Requirements of Senators:
  - Min. 3 units at SDCCD w/ a majority of classes taken at Miramar College because you're representing Miramar students.
  - Cumulative 2.0 GPA before and throughout term of office.
  - Must attend all ASG meetings (9-11AM).
  - Must attend constituency meetings (Office hours and committee meetings) throughout the term.
  - Office hours will be further discussed in future meetings.
- E. Fall Fest (9/18) | 5 minutes
  - a. Joseph Hankinson - AKA Club Rush from 12-2 PM.
  - b. VP X - Can office hours be used for attending/tabling for these events?
    - Joseph Hankinson - up to interpretation (technically yes).
    - Dean Barnard - Office hours will be put on the agenda next week.
      - Allocate at least 3 hours to office hours [(in ASG Office or Senator Projects (will be discussed later))]; no more than 3 or 4 senators during one time.
      - Thinking we will record like last year - Excel sign up sheet and record in the book in the Student Affairs Office.

    - IF ASG wants to do another Fall event, this could be it.
    - Budget approval would be needed if we decide to approve the event later.
    - Blaize (didn't catch last name) - Muses Club is thinking about doing an Open Mic session during that time, so we could possibly do a collaboration.

  - a. Joseph Hankinson - Already in the budget we approved. ASG is involved in this event annually.
    - ASG invests in a gift basket for donors.
  - b. Dean Barnard - At Valley High Restaurant on a Harbor Island Venue (the same as last year).
  - c. Formal event where student representatives attending can mingle/network with donors, bidders, for the SDCCD.
