 - 1. Reason for Proposed Action: Revise course to propose and submit for Cal-GETC Area 1B Critical Thinking, May 2025.
 - 2. COMS 160 is currently approved for the CSU GE Area A3 – Oral Communication.
 - 3. Cal-GETC Area 1B courses must have a prerequisite of an Area 1A course, which is why ENGL 101 and 105 have been added to the prerequisite section.
 - 4. For UC and Cal-GETC standards, there must be a demonstrated pattern of revision and critical thinking. This is reflected in the catalog

description language regarding “the writing and revision of a sequence of critical compositions as a foundation for oral debate.”

5. This course will need to be approved at the next CIC meeting to meet the Cal-GETC deadline for Fall 2025. Chair Hall will add to the walk-in list.
