Dean Julian will present a template for the 2025-2028 Student Equity Plan.

- Dean Julian presented a brief overview of what the Equity Plan consists of, the criteria and measurements for the plan, and the process of approval. The plan is to decrease disproportional gaps within impacted groups in San Diego Miramar College. The 2025-2028 Student Equity Plan is due for submission on Sept. 30th.

V. NEW BUSINESS

A. **Reallocation of the Budget** | 10 minutes

Treasurer Sindhu Narasimha will lead the discussion about the reallocation of the ASG budget for the Spring semester.

B. **Board of Trustees** | 10 minutes

(President Hailey Hua | Information/Discussion)

President Hailey Hua will provide a brief overview of what is going to be presented to the Board of Trustees meeting that is happening today.

- Pres. Hailey introduced the questions that will be introduced to today's Board of Trustees meeting. Feedback from the student body was provided during the discussion while reviewing each question.
- Question 1: What is one item Miramar College is doing that you are proud of and would like presented to the Board of Trustees and College Leaders?
 - A couple of students mentioned the successful participation and awareness of events and activities on campus.
- Question 2: What is one item our Associated Student Government is currently working on that you would like to report to the Board of Trustees and College Leaders?
 - A few students mentioned the work in progress and/or success for Senator Projects, especially for menstrual product accessibility, as well as the work put into the resolutions submitted. Another student also brought up improvements made toward club funding.
- Question 3: What is one item that you would like to see improved at Miramar College that students have expressed the need for?
 - Student responses included: A request for extending open library times, improving public safety, OER and more accessible academic resources, and mandatory training among all faculty members.

C. **Senator Project Update** | 10 minutes

(The ASG Executive Board | Information/Discussion)

The ASG Executive Board will talk about updates regarding Senator Projects starting from Fall 2024.

- Senate Rep. Blaize Fonseca led the discussion.
- Fitness Center Project
 - An update by Sen. Matt. Price will be given during the Public Comment section of the meeting.
- ASG TikTok Project
 - Sen. Rayyan Talal Ahmed reported that progress has been stalled this semester, especially due to the leave of his groupmates.
- ASG Canvas Shell Project
 - Sen. Ryan Pacheco reported that they are thinking of combining it with the existing Canvas Shells involved with ACP
- San Diego Promise Program Project
 - Sen. Tara Patel reported that their group has not started much progress this semester, but they created a plan of action last semester that focused on more short-term things such as spreading more awareness at Miramar and coordinating informational high school presentations for possible incoming students. They are currently working on meeting with the Dean of Student

Affairs.

- Menstruation Product Accessibility & Maintenance Project
 - Sen. Anchal Verma reported a notable sign of progress with Senator and Delegate Chloe Kim's resolution regarding the project. They are also working with Sen. Claudio Nevells to plan for Women's Empowerment Week in March.
- End of the Year Banquet Project - Frankco and Titus: shifting to marketing. Clubs or transfer focus. Using Instagram and social media.
 - Sen. Frankco Wong reported that he and Sen. Titus Balch are shifting to marketing toward clubs or transfer students and are using Instagram and other social media platforms to market for their project.
- Everyone seemed to want to continue their previous Senator projects.

- b. Dean Barnard
 - The Collegewide Planning Summit will be held on March 14th from 8 AM - 3 PM in K1-107 (the usual ASG meeting room). The Planning Summit deals with ways to help students persist throughout college. After the meeting, the Executive Board needs to decide whether they want a regular meeting or for people to attend the Planning Summit, which will provide an opportunity for faculty members to hear students' input.
 - The Commencement Ceremony for graduation starts at 9:45 AM (date of the event was unable to be recorded).
 - People graduating or transferring need to apply for graduation to achieve the degree they're working toward.
 - They also need to sign up to attend the graduation ceremony. Information for that comes out around mid-March.
 - They are still looking for commencement speakers, who will either be an actual commencement speaker or people who are graduating. Those applying will submit a draft of their speech, and if chosen will work with Professors to further improve their speech and to improve their public speaking skills in preparation for the ceremony. Time commitment is crucial.
 - She reminded everyone that Advisor Joseph Hankinson has a timeline for when the ASG elections are going to be held for the positions next-year. They need at least 5 Senators to begin doing things for the next year. She asked everyone to spread the word about the elections.
