1. Approval of agenda
 - Request to add “Changes in Subject Indicators for AB 1111” to Item 9, *Other Business*.
 - Request to add “Check Walk-In List” to Item 3, *Review of Curriculum Proposal Tracker*.
 - Agenda approved, with revisions, by consensus.
2. Approval of notes from last meeting
 - Tabled until next meeting
3. Review of [Curriculum Proposal Tracker](#)
 - Filtering and sorting functions
 - Short reviewed the functionality of the tracker, and emphasized that committee members can apply specific filters and sorting based on their position (Articulation, Tech Writer, Chair, etc.) and workflow preference.
 - “Default” view
 - Default should be: sorted alphabetically by the “Identifier” column, and then filtered on the “CIC” column to only show “Blanks” and “Held”.
 - Chair Hall added column A for notes/action items.
 - Best practice is to reset sheet to default view when you are done working with it.
 - Determining agenda category
 - The “Agenda Category” column is completed by the Technical Writer. This column helps determine where the item will be placed on the Curriculum Committee agenda.
 - Revision vs. Consent

- Consent is generally used for routine items that don't need to be closely reviewed. Consent items are further divided into two classes:
 - Impacts: An item in being impacted by another change (e.g., when a prerequisite or class list for an award is changed, so we need to update the award accordingly).
 - Non-substantive: A routine update that doesn't impact the critical features of the course/award in any way (e.g., 2- or 6-year reviews with no major changes, textbook updates, etc.)
- Proposals from another college that are also active here are not consent items – we should include on our regular agenda.
- Proposals from another college that are not active here do not even need to be on the consent agenda – they can just be listed as informational items (FYIs)
- Though the Technical Writer will choose the categories on the spreadsheet, the Chair should still review when creating the agenda (especially for consent items).
- Check Walk-in List
 - Compared tracker against 9/26 & 10/10 Walk-in Lists; updated tracker as needed
 - CHIL courses – effective dates will need to be updated by tech writers; won't make Fall 2025 deadline.
 - Earth Sciences AS & Exercise & Nutritional Sciences AS – may be removed from Duane's tracker & proposals deleted, since we are not proceeding with the MATH 141A/B implementation.
- 4. Fire Fighter 1 Academy CA project
 - Review list of necessary proposals (from Veronica)
 - Because of deactivations & new courses, we will need to modify seven programs.
 - Need for a crosswalk (how do new courses correspond to old ones?)
 - Catalog deadline for 2026-2027 will be in May 2025 – May 8th is the last CIC meeting for this catalog.
 - Review list of needed documentation
