# President's Report: State, District, Campus, and Senate Issues Campus:

- 1. UPDATE on question from last A.S. meeting: Exploring better dates for student deadlines e.g. ones that don't conflict with holidays (the class drop deadline) or land on Saturday (commencement deadline), etc.
  - a. The overarching position at College Council is that we do a better job of ensuring folx are aware of these deadlines, and their modality (in person or online only).
  - b. Add/Drop Deadlines: this is based on the Census Date, in Ed. Code (there is nothing we can do to change that). However, a colleague shared that a 16-week in-person classes had an add-drop date of 2/14 whereas their 12-week online class had an add/drop date of 2/20. They both started 2/3 and the 12-week class should have had an earlier and not later add/drop than the 16-week course. (I will follow up with the District about this.)
  - c. Petitioning to Graduate with an ADT: District Evaluations Office sets this deadline—contact them if you have interest in modifying it.
  - d. Commencement: Executive Cabinet at the District sets the dates, but the deadline is set locally in Student Services to be two weeks before the commencement
- 2. UPDATE on question from last A.S. meeting: Faculty would like some discussion on what's driving the start date. (It doesn't fit with other schools, so we'd like to explore that. There are a lot of unforeseen impacts.)

- a. Chancellor Smith shared that this is a decision made by the AFT's committee— if folx have input, they should share that with their AFT rep.
- b. Regarding the academic calendar (class start and end dates, etc.), this is overseen by the AFT. Folx should contact them to get involved. (See also Member-at-Large, Olivia Flores' report in today's meeting.)
- 3. UPDATE on question from last A.S. meeting: Will Miramar continue offering 4-week courses?
- a. VPI Odu shared that this is a local decision, not a District-wide mandate. Miramar's position is that we will not be offering four-week classes (until we can streamline our enrollment verification process) because of the difficulty in identifying fraudulent students in time to ensure the class has enough actual students to be productive (i.e. not cost us money to run). The SDCCD is buying software to help us with this.
- b. At Chairs Committee, folx shared that there may be another solution, such as only enrolling "verified students" since there's not enough time to verify SB40 students (SB40 students have applied to SDCCD but not completed any of the verification steps).
- 4. Regarding the proposed Adjunct Directory on the college website: after discussing this at various committees, the college wants adjuncts to work with their chairs directly about being on the department website. Chairs will then work with their Deans about how it will work, etc.
- 5. Reminder: if you are a contingent (aka adjunct) faculty member serving on a committee at Miramar (or anywhere in the SDCCD), please be sure to read and complete the process and form ASAP: <u>AFT Adjunct Shared Governance: Committee Service Process</u>.
- 6. Culturally Responsive Teaching Symposium: Friday, April 11 in person at Miramar. Join your faculty colleagues in a day of learning about culturally responsive teaching and practices! Presenters including Miramar participants in CREATE (Culturally Responsive Educator Academy & Training for Equity). The keynote speaker is Dr. Laura Rendón. Please see the recent email from Dean Nessa Julian for the flyer and save the date; more information will be shared in the next few weeks.
- 7. Updates from the <a href="2/25/25 meeting">2/25/25 meeting</a> of <a href="College Council">College Council</a> (link to the <a href="recording">recording</a>):

- i. Carrasquillo suggested to discuss at a future leadership meeting, since this is public comment. Consensus.
- ii. Kunst will note the next Website Advisory Committee date on the next agenda.

- iv. Lundburg responded that he will discuss with VC Topham; Odu will discuss with VPIs; another place would be DGC. Martin thank you; will bring that forward.
- v. Lundburg asked Kunst and the Classified Senate to identify where we are not doing so this so we can address it.
- vi. Miramontez will get the report filled in and bring it back as FYI; he will submit it to meet deadline.
