President's Report: State, District, Campus, and Senate Issues Campus:

- 1. Changes to class caps: The VPI has been working with Department Chairs on revisiting Class Caps—please contact your department chair for details. - 2. College Council approved the development of a small workgroup to explore the feasibility of implementing a Puente Program at Miramar. They are looking for three participants per constituency group. If you are interested or want to learn more, please contact me, pmartin@sdccd.edu.
- 3. Because Miramar is now operating under the 2024 Accreditation Standards, the Office of Institutional Effectiveness is asking all Committee and Subcommittee Chairs to ensure that they are aligning specific agenda items to the accreditation standards. (You can see we started doing this on this week's A.S. agenda.) Please see the new 2024 Accreditation Standards as well as SDMC Mission Vision Goals and Standards 2025 document I created to assist with this purpose. It is important that this change be implemented given that we use this alignment to show how decisions are being made across the college (via agenda items). The ASCCC will provide faculty participants a \$150 stipend for each CCN Course Template created."
