


AS Code of Conduct

3. Land Acknowledgment

We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people, who have lived in this area for well over 10,000 years, and we honor their past, present, and future connection to this land and its inherent connection to their identity.

We acknowledge our occupation of unceded Kumeyaay land and the violent systemic injustices this has continuously perpetuated for Native peoples of this region. We pay respect to the Indigenous people of San Diego County - past, present, and future - and honor their continuing presence in their homeland and their spiritual beliefs that land does not belong to people; people belong to land.

We also acknowledge that this is merely the beginning, and there is far more work to be done in an attempt to heal all of the injustices and inequities that still exist today and throughout their entire historical diaspora. Hopefully we can find a way to move forward together.

- 6.3. Specifying Guidelines for Adjunct Committee Service Payment Pablo Martin (5 mins + 5 mins Q+C)
 - This effort is designed to encourage SDCCD contingent (part-time) faculty to participate in shared governance and ensure they are paid a reasonable hourly rate.
 - The CBA provides the AFT with \$50,000 per year to fund adjunct faculty shared governance efforts—this comes out to \$22,000 per semester.
 - The higher the number of hours submitted per semester, the lower the hourly rate, and vice-versa.
 - The rate for Fall 2024 was roughly \$70/hour (with 314 hours across the district)

- 6.3. Specifying Guidelines for Adjunct Committee Service Payment
 - Proposed Guidance for Payment (the ASPs are working to achieve consensus on the following)
 - Committees and work groups must be clearly related to 10+1 business (this excludes operational committees, event planning work groups, and the like)
 - 2. Paid hours would be limited to 20 hours per adjunct per committee, or workgroup, per semester. An adjunct faculty member could serve on multiple committees, however.
