A. Governance Committee Constitution Changes | 5 minutes

(Governance Committee | Information/Action)

The Governance Committee will briefly review amendments made to the Constitution and will conduct a vote for approval.

- The Governance Committee added a stipulation for presidential candidacy qualifications. They initially wrote for the student to have completed one academic year in order to be eligible to run.
 - Senator Matt. Price motioned to approve the amendments. Senator Nicole Le seconded.
- Advisor Joseph Hankinson mentioned that the qualifications were supposed to be some ASG experience prior to applying for presidency. Senate Rep. Blaize Fonseca agreed to change it to what Advisor Joseph Hankinson was suggesting.
 - The Miramar College Engineering Club Rep. motioned to approve the new and full changes from one academic year to at least one semester of ASG experience. Senate Rep. Blaize Fonseca seconded. since the last time they made amendments
 - Vote: There was a unanimous vote by the body to approve the new changes made to the Constitution.

- a. Joseph Hankinson
 - The Send Silence Packing Event is on April 24th. They are still looking for volunteers.
 - Orientations for graduation will be happening on April 29th and 30th. Those attending will have to RSVP.
 - Chill With Us will be on May 1st. All clubs are invited. It will be similar to Spring Fest./Earthchella where there will be games, arts and crafts, and boba with the addition of therapy dogs.
 - In addition to the AAPI Ceremony, there will also be a Lavender Celebration for the LGBTQ+ Community on May 6th from 4-5 PM and a La Raza Event for Hispanic students on May 8th from 5:30 to 8 PM.
 - There will also be a Rite of Passage for Native American students.

 - On May 6th, there will be a mental health event called “Be Kind to Your Mind” with Kona Ice from 12 to 1:30 PM.
 - There will be an ASG Orientation on May 23rd for incoming and outgoing ASG members with breakfast and a BBQ lunch.

b. Dean Barnard

- The election packets have been checked. Everyone qualified is currently unopposed. Campaigning starts today. If a candidate receives one vote, they will get elected, plus the candidates can also vote for themselves.
- So far, there are 8 running Senators and 1 President, Vice President, and Secretary. There will be an In-House election in the Fall for Treasurer and the rest of the Senator positions.
- Current ASG members should make it a priority to attend the Friday meetings. There are 3 more meetings left with some action items needed to decide upon. The body needs to meet quorum in order to vote on the minutes from the previous week's meeting on the last meeting.
- With the current administration cutting funds from a lot of colleges, there have been budget concerns. There is a law with a State Education Code where 50% of the money the college receives has to go to academic services, so support programs may receive funding cuts if necessary, but Miramar College can sustain about 2 years of cuts before that is a possibility.
