1. Call to Order

- The meeting was called to order at 3:34pm.

5. Action Items (this includes second reads)

- 5.1. Proposed GEs for SDCCD Bachelor's Degree Programs Isabella Ela and Shelly Hess
 - <u>Baccalaureate Degree GE Proposal</u>
 - Summary Baccalaureate Degree GE Proposal
 - SDCCD GE and CalGETC Chart
 - Q and A for GA and BS Degrees
 - Hall presented the history of this item: The deadline is March 27th. Miramar's CRC rescinded their virtual vote and had further discussion. They voted again at their last meeting and it passed. It is being brought to the A.S. so Ela and Hess could address issues.
 - City has already passed it and it is expected to pass at Mesa this week.
 - Hess shared further history and details.
 - Ela walked senators through the GE. They are not removing any GE, just adding to what is already in existence.
 Students would be graduating with an Associates as well. It will affect nine degrees at Miramar. This is to compensate for Miramar students who, unlike their counterparts at Mesa and City, are not being grandfathered into their existing Associate Degree GE requirements.
 - Discussion ensued.

 - The motion that was approved at Miramar's CRC: Approve the establishment of a local, SDCCD lower-division general education pattern for baccalaureate degree programs and approve the addition of SDCCD associate degrees that lead to an SDCCD baccalaureate degree to SDCCD General Education Option 4.*
 - *Consider adding language to ensure that all of the students in local B.S. degree feeder AA/AS programs but don't plan to enroll know they will need to take more classes if they want to get into a CSU or UC.
 - Motion to approve passed with 30 yays, 11 nays and 2 abstentions. [Arancibia/Moeller]
- 5.2. Public Art Procedure Hannah Pierce
 - Facilities Committee decides what is "art."
 - This is City College's procedure that was adapted to Miramar College (see red font).
 - Motion to approve the Public Art Procedure passed unanimously. [Booth/Carrasquillo]
- 5.3. Interpretation of the Brown Act Regarding Teleconferencing and Attendance Pablo Martin
 - Motion to approve the following motion passed unanimously. [Booth/Kjartanson]

- Senators who attend an Academic Senate meeting at a remote location that is not listed on the agenda will be considered technically absent. They will be listed as "attending as a guest" in the minutes for that meeting.
- Senators who attend an Academic Senate meeting in person but listed a remote location on the agenda and do not
 post the agenda at their remote location along with a note informing the public they will need to find another
 location from which to participate in the meeting will be considered technically absent. They will be listed as
 "attending as a quest" in the minutes for that meeting.
- Because technically absent Senators have made a good faith effort to attend that A.S. meeting, their absence should not count toward the three absences that would result in a Senator being replaced by another member of their constituency group.
