- A. Call to Order: The meeting was called to order at 10:31 a.m.

## C. Committee Reports:

- <u>Budget and Resource Development Subcommittee</u>: Is continuing work with Nuventive, and it is going well. Had first review of outputs from staffing requests (fine tuning is needed, but encouraging).
- <u>Program Review/Outcomes Assessment Subcommittee</u>: Next meeting will be working on SLO Course Assessments response that was identified in SPAS 2.0. As well, will continue conversation with alignment mapping regarding strategic goals and directions.
- <u>District Strategic Planning Committee</u>: Committee met, focusing on the assessment of the District Strategic Plan. College IE Deans met with VC Fischthal on how colleges can contribute to progress on the district goals stated in their strategic plan. At the college level, will be using Nuventive to crosswalk the college's objectives and strategic goals that speaks to the District's strategic objectives. Will be providing status updates on the aligned objectives to the college's strategic goals. Twelve objectives will be selected from the district strategic plan (from 62 objectives, two per goals). Upon cross-collaboration review/using a bi-directional approach, this will then be showcased during at a spring Board meeting.

#### E. Old Business:

ltem Planning Summit 2025 Update - The format of this summit will be focused on learning outcomes and a college specific definition of persistence, as well, review actions from previous summits that successfully contribute to increases in student performance data (via Guided Pathways efforts, Equity efforts, etc.). Will be expanding definition of persistence beyond the technical, which will include the following based on literature review (qualitative focus); a. Based on PREDD data, will be looking into factors (academic, psychological, financial and economic, institutional and environmental, and personal factors that applies to the college and our student population, b. Looking into data on why students are dropping courses (District's Enrollment Dashboard), c. Connection with Student Success Committee efforts, d. Milestone persistence Re(definition) based on selfidentified student educational objective (certificate/degree), and e. major buckets in the student journey (preclass, Classes, student campus engagement, support (both personal non-cognitive and non-academic wraparound services for in class success). Participants of this summit will be working on intra-group dialogue by the student journey/major buckets, as well as an inter-group dialogue that brings cross-functional teams together to address the student journey based on persistence data – to share best practices. Simultaneously, the Student Success Committee Workgroup is mapping out the student journey (looking at loss-momentum and sticking points), which can be used for this summit. The hope is to get strategies that can go back to the Student Success Committee on what can help with student persistence. To note, the Student Success Committee Workgroup is looking at the actions that have been taken as a college, while the Planning Summit Workgroup is looking at the technical definitions (and building out from there). These are two bookend workgroups that are working towards the same goal of what persistence looks like for us as a college. Lengthy conversation continued in regards to persistence definition, student population to be captured, how it applies to an open-access system/college, narrower definition to use in SPAS 2.0, and how to look at and approach persistence data – a structure for the college community on how to move into the same direction. Also touched on was the importance of selfidentification of roles on campus and how these roles can impact students' sense of belonging. Agenda will be worked on, and flyer will be sent out by President's office. Will be looking into announcing summit at the Spring Kickoff in January.

- 2 <u>Miramar Educational Plan Update</u> Miramar Educational Plan went to College Council and will move through constituencies for vetting and approval.
- 3 Strategic Plan Mid-Cycle Review: SPAS 2.0 Progress Update Tabled.
- Vision Aligned Reporting (VAR) Update Second training was held with implementation leads. Went over the VAR platform. As well, went over homework where programs are going to crosswalk their functions with the VAR categories and subcategories. At the next VAR training, implementation leads are going to log into their account and start inputting the data (as an exercise). Sample was provided by EOPS that cross walked their activities with VAR activities (with reason codes). A deeper conversation will be needed in regards to connecting outcomes with financial information to open project account structure so that we build the project accounting chart of accounts to match the activity outcomes (i.e., expense, projected time used on project, operational resources tracked, grant used). Suggestion was made to look into Project Accounting module in Peoplesoft and to have an executive-level conversation with connecting outcomes and financial information.
