President's Report: State, District, Campus, and Senate Issues

Campus:

1. Two committees have submitted changes to the CGH Changes Workgroup—please contact Pablo Martin ASAP if you have concerns about them:

2. Adjunct Faculty Shared Governance Funds: Working with and upon the recommendation of AFT President Jim Mahler, the four A.S. Presidents agreed that each college would receive 110 hours for distribution for its adjunct faculty shared governance committee work for the fall 2025 semester. If the total number of hours submitted for pay at the end of the semester is less than 440 hours collectively, then the rate of pay will increase accordingly for that semester. Please contact your AFT Rep, Olivia Flores, or A.S. President, Pablo Martin, if you have questions or concerns.
3. Clarification on Dual Enrollment presentation at A.S. on 4/22/25:
 - a. CCAP FTEF and Miramar FTEF allotments are separate.
 - b. However, last academic year (2023-24), a certain number of CCAP courses were promised to high schools 9 months ahead of time (when they were making their schedules). That promise had to be kept, so Miramar was forced to use their FTEF to do that.
 - c. Matt and Randy recommend that all chairs communicate with each other and their Deans to ensure they are using their CCAP budget most effectively.

District:

1. District IT Services has officially kicked off an ERP Single Sign-on (SSO) project to be implemented Fall 2025. Please see "[SDCCD 2025 ERP Single Sign-on Project.pdf](#)" for more information.

State:

1. The Academic Senate for California Community Colleges (ASCCC) annually seeks nominations for faculty members to fill two (2) seats on the Board of Governors. The deadline to apply is June 30th by 11:59 pm. ("[Board of Governors Call for Applications.pdf](#)")
2. Following are some key changes in the May Revision compared to the January proposal:
 - a. Under the May Revision, the overall state budget would be slightly lower than proposed in January but still higher than the 2024-25 enacted budget, increasing by about 8% to \$321.9 billion, with a projected budget deficit of about \$12 billion rather than the roughly balanced budget expected in January. General Fund spending would increase by about \$15 billion (7%) to \$226.4 billion.
 - b. The revised proposal for ongoing spending includes about \$217.5 million for a 2.3% cost-of-living adjustment (COLA) for community college apportionments, about \$12.9 million less than the Governor's January proposal included for a COLA of 2.43%. It includes an additional \$27.7 million for COLAs and adjustments to certain categorical programs. The proposal includes \$139.9 million to fund 2.35% enrollment growth, a substantial increase over the \$30.4 million for systemwide enrollment growth of 0.5% that was previously proposed.
 - c. The revised proposal eliminates one-time funding previously proposed for the Statewide Technology Transformation, and reduces the funding proposed for the establishment of a Systemwide Common Data Platform, scaling up Credit for Prior Learning, and developing a Career Passport.
 - d. The Governor's revised proposal includes \$68.5 million in capital outlay funding from Proposition 51 and Proposition 2 to support the working drawings and construction phases for one continuing project and the

- preliminary plans and working drawings of 29 new projects. Consistent with the agreement included in Assembly Bill 176 (2024), the revised proposal provides \$4.2 million in capital outlay funding from Proposition 2 to address life-safety concerns for the Davies Hall project at American River College.
