Board of Governors Call for Nominations

The Academic Senate for California Community Colleges (ASCCC) annually seeks nominations for faculty members to fill two (2) seats on the Board of Governors. These faculty members serve staggered two-year terms and are appointed by the Governor from a list of recommendations submitted by the ASCCC.

The ASCCC Executive Committee will use specific criteria outlined in the attached description to select nominees for these faculty seats. Candidates should be articulate, capable of presenting reasoned arguments on educational policy, and knowledgeable about statewide educational issues. Faculty members who are well-versed in the challenges affecting both faculty and community colleges are crucial to this role.

While we are particularly interested in candidates who represent and have demonstrated a commitment to issues of diversity, the ASCCC has broadened the criteria to encourage leaders with a variety of experiences to consider applying for this position. Diversity remains a key consideration, and the ASCCC encourages leaders from various backgrounds to apply. **It is essential that all faculty members are aware of this important opportunity to serve.**

Nominations can be submitted by any college or district senate member or ASCCC Executive Committee member. Nominees are encouraged to include a letter of endorsement from their local academic senate. Previously nominated faculty members seeking reconsideration should submit a letter of intent along with a current

resume to the ASCCC Office.

Candidates interested in nomination should:

- Complete a Board of Governors Nomination application,
- Provide a statement of intent,
- Submit a current resume detailing relevant professional activities, and
- Ideally, include a letter of endorsement from their local senate.

The deadline to apply is June 30th by 11:59 pm. All original materials must be received by this time.

Nominees will be selected and interviewed by the Executive Committee at its September 18-20th meeting (exact location to be determined). All candidates will be notified of the outcome of the nomination process.
