III. **Old Business**

#	Item
1)	<u>SSC & Committees Coordination:</u> Ongoing discussion of bi-annual summits, etc. The proposed committee coordination plan was shared with all constituents, with the exception of ASG. Additionally, the PIER Committee reviewed, made recommendation for there to be ample time to review and make recommendations based on the areas of focus for alignment with the planning calendar. No discrepancies or edits were noted by SSC, therefore no need for a workgroup to convene. Nessa will review plan once more before presenting to College Council.
2)	Student Journey Update Roberts working on a focus group with students for the Program Mapper in Fall 2025, however may meet informally with campus staff in the summer. Demcho shared the Marketing and Outreach Committee is working on creating a view book. This is an effort to simplify information for students, suggestion was to include student journey information. The team discussed the need to simplify the project of the student journey, ultimately deciding to continue working on it over the summer, with a smaller work group consisting of Dan Roberts, Monica Demcho, Malia Kunst and Chey Morence. Will reach out to members of initial workgroup as well to see if they would like to participate. The goal is to keep the project simple and relevant to all students.
3)	2025 – 2028 Student Equity Plan Update on equity history story, workgroups, and timeline. Julian and Carrasquillo discussed the progress of the 25-28 equity plan. They have received many thoughtful responses from the campus and are forming work groups based on the metrics. They are creating a workbook for the work groups, including information on all data, equity definitions, and themes from the planning summit. Additionally, finalizing a timeline for the work groups. Julian and Carrasquillo are open to anyone interested in being part of the work groups to come and discuss. The next scheduled drop-in session called the Equity Story Coffee Hour is 5/20 from 1:00 – 2:00pm in I-107. The draft of the Equity Plan is expected to be completed by September, with a presentation to the board in November.

#	Item
1)	District Student Services Council report Gonzales shared the last Student Services Council meeting was 5/1, which covered the information campaign related to common course numbering; Digital parking permits for students will be implemented Summer 2025. Students are only permitted to register one car per permit. Fraud issues continue to be an issue districtwide, periodic drops are implemented before the semester. He also mentioned changes to Title 5 education plans, provided clarification that these changes would not impact the equity plan reporting.
2)	<u>Student Profiles 25-26</u> Discuss plan to coordinate student profiles for banners & website profiles Julian shared we are moving forward with year two of the project. The intention is to feature students on the Miramar website and refresh banners displayed around Compass Point. She outlined the process, including soliciting nominations, reviewing students, and scheduling photo shoots. The project aims to showcase approximately 20-25 student profiles, with a focus on representation across the campus. The banners will be displayed at the beginning of the semester, and the team is open to suggestions for the prompts used in the student profiles. An email will be sent to the DL for nominations.
