- A. Call to Order The meeting was called to order 1:02 pm.
- **B.** Permission to Record Meeting There was consensus to record the meeting.
- **C. Land Acknowledgement** We recognize that San Diego Miramar College sits on the ancestral homeland of the Kumeyaay people, who have lived in this area for well over 10,000 years, and we honor their past, present, and future connection to this land and its inherent connection to their identity.
- D. Approval of Agenda Halaseh made a motion to approve the 10-14-25 meeting agenda. Seconded by Gomez. There was no discussion. There were 10 yay votes, 0 nay votes, and 0 abstentions. The motion carried.
- **E. Approval of Minutes Battisti** made a motion to approve the 9-23-25 meeting minutes. Seconded by **Halaseh**. There was no discussion. There were 10 yay votes, 0 nay votes, and 0 abstentions. The motion carried.
- **F. Public Comment -** There was no public comment. **Gomez** asked to clarify public comment. **Lundburg** responded that it is really for folks that want to speak to want is on the agenda. We are trying to stick to constituencies bringing forward items.
- G. Committee Reports/Other (2-3 minutes)
 - President's Report Lundburg shared that the district is anticipating a State Block Grant, to be announced next month, at about \$2M. It should be enough to cover our HSI STEM program and City's AANAPSI program. Measure HH: He shared that meetings are happening with our Design Build Teams for the Child Development Center, Aviation, and the Performing Arts/English Gallery.  - AS Report Gomez shared that A.S. met on 10/7 there was contention on meeting modality, and the hybrid technology in the classroom failed. The mission and vision statement were reviewed and discussed adding a "catch all" senator back. Districts new software request process was approved. Reviewed the Academic freedom board policies. Supportive in the classroom. First read of student equity plan. Contract hiring list at next meeting. Al things that are on-going.

- CS Report Kunst shared that the C.S. met on 10/7 The mission and vision statement were reviewed. There was a CRM Update presentation. A first read of the student equity plan. Had a second, second read of the technology plan. The agenda was full and did not make it through all the items but continuing to work on a professional development plan and a training plan along with our 9+1 implementation.
- ASG Report Halaseh shared that ASG met on the 26th and the 3rd; hosted a leadership conference on the 10th. Puente Program lots of discussion and engagement. Senators chose to not support it and not move forward. Felt it was too much money and in-kind support for the limited number of students it supports. Discussed Land Acknowledgement, approved amendment with IDEA committee to continue working on it. Senators would like to use the shortened version for meetings and longer version for events. PD workgroup Senators Adam, Anchal, and Jing (exec members) and Michael Fuzzi have been appointed. Dry run of recording meetings. Meetings focused on team building and cohesion. More collaboration with Mesa and City. Lundburg, thank you; heard about that Puente discussion, that's great.

report back to this group as well. Puente Workgroup Report Gonzales Attachment: Puente Program Implementation Exec Summary Gonzales, collecting final input from constituencies. Halaseh shared, on behalf of ASG, there were some questions around eligibility criteria for the program, if campus would be affected by the shutdown, concerns that grant will not exist or be cut, how big the group/effort is, overall, concern that we are taking away resources from others to do this. ASG would like to find ways to make it more effective. ASG took a roll call vote, and did not support the program, with a 4-5 gap in majority. Carrasquillo shared that A.S. supported the program. **Kunst** shared that C.S. voted to support the Puente program exploration, noting we have concerns with long-term institutionalization and staffing. Gonzales, management had similar conversation and concerns, but overall, supported taking the next step. Kunst, also, only college in SD county that doesn't have this program, and does us a disservice. Halaseh felt there was a lack of clarity for program overall. **Odu**, asked if we have counseling outcome data. Gonzales responded that he can talk to counseling and bring some data to the next meeting. Halaseh – last year, ASG discussed counseling services, and felt that is trickling into this year/conversation. Gonzales discussed with counseling and it would take away a full-time position. They put in a request for an Equity counselor, if they get that, this position could support this program. About 40% have an Ed Plan, meaning 60% don't. Julian asked if we have disaggregated data. Gonzales responded not really, data was inconsistent and we don't have a student services dashboard. Barnard shared the data we do have is more for general counseling. Gonzales shared that he will take this back to Executive Cabinet to discuss, and will report back here. Carrasquillo noted that Miramar is HSI, which means 20% of our students identify as Hispanic, and we should think about the ROI. Let's go back to the why. There will be a greater result in the end because we addressed an equity gap. Halaseh shared that he presented that, and ASG had the discussion. We're not saying they won't be successful, but put off by the number of students (25) we are serving and how much of our resources are needed, long-term. Lundburg, thank you. He reiterated that we know the program is successful, and we support it, but we need to be responsible with the resources we have. It looks like we have enough support to continue exploring further and this discussion can better inform what we do. **Gonzales** thanked everyone and noted we are still on track with our timeline. College Council Goal Setting 2025-2026 Lundburg/ Attachment: Standing Committee Reporting Form-CC Kunst Kunst reviewed the goal setting form for College Council, noting that she made the edits we discussed at the last meeting. Kunst reviewed the Student Journey Map. She noted that this was routed and reviewed in the spring. There was still some concern on language. There was a small workgroup over the summer that worked on it. The committee has reviewed a few times and we like where it is. The Student Success Committee has a goal to maintain this document and evaluate it annually to make sure it stays current and aligned with steps for students. The next steps were to present it here, informationally, and to make a visually appealing version that could be printed on flyers and handouts for outreach events, like Jets Jump Start. We also hope to coordinate with website services to have this housed the website and make it interactive, with links. Carrasquillo shared a suggestion for check boxes from the IDEA Committee.

Kunst liked that idea, and will take it back. Gonzales noted that Outreach is working on a viewbook, could this be linked there? Kunst responded yes, and the committee discussed as well, and liked the idea. We hope to mirror this with the Campus Resource guide too. Any additional feedback can be sent to the Student Success Committee.

4 Environmental Sustainability Subcommittee – request for website space to house sustainability efforts at Miramar.

Lain introduced herself as the chair for the Environmental Sustainability Subcommittee and shared that she is here to talk about requesting website space for sustainability efforts on campus. She became the chair in 2022 and in fall 2023, she brought the College Initiatives idea to Hill. That worked its way up, but there is no mention of sustainability efforts yet. Also brought this to the website task force last month, and sounds like it is doable, but need to work its way up and come to College Council. Efforts they would like to highlight include, the Vernal Pools information, research projects, and bi-annual cleanup. There are also news clips that could be housed as well as information on our Native Plant Walk. This is currently housed on a wix website. There is also the LEAF program, as we offer LEAF classes, which have a focus on sustainability. There are also documents, like resource map which shows water refilling stations and recycling stations, a check list for sustainable practices and planning events, and a sustainability syllabus statement. In the future, hope to work on a climate action plan, in alignment with the district sustainability committee. She is aware of the concerns as to who will maintain the website, and as of right now, the Sustainability Committee is committed to maintaining that website space. In the future, as it's passed with other campuses, our academic committee is looking to bring a resolution to the A.S. to have a sustainability officer on campus. Hopefully, this can be something that they work to maintain in the future. Lundburg clarified that she is looking for action from this group. Lain confirmed. Kjartanson made a motion to approve ESC's request for website space. Seconded by **Odu. Gonzales** asked if there is a suggestion on where on the website it would exist. Lain responded hopefully, College Initiatives, but open to it. Lundburg asked Lain to take that back to the committee and let us know. Lain confirmed. Halaseh shared that ASG is very supportive, looking forward to collaboration. Julian, LEAD office is working on culturally responsive event planning guide, would love in include sustainability. Opportunities with NASSSP too. Halaseh asked about greenhouse access. Lain noted there have been some maintenance issues, but we do house some plants there. Based on student interest. **Kjartanson** and **Odu** withdrew the motion. <mark>Lain will bring this</mark> to Facilities, Health, and Safety Committee (FHSC), which is the parent committee, and will bring back here for action.
