V. NEW BUSINESS

A. Pre Med Club Budget Request | 10 minutes

- a. Isaac (Pre-Med Club Rep) - The Pre-Med club is planning to host a CPR/AED class for free for anyone who wants to join. Explained why CPR is important. Some healthcare professions and other jobs may require a CPR/AED certificate. Went over what the certification includes. The cost is \$240 in total for 12 people (\$20 per participant). Through outside sources, it would usually cost around \$60-\$100 for a course. The club wants to cover the whole cost for the students.
- b. Treasurer Michael - if more than 12 people show up, will the school be able to honor the \$20 per person? Isaac - if there are more people, they might have to turn them down. But, since their club has been getting an irregular number of members, they don't expect more than 12 people to come. The club might have backup funds in its club funds to cover the cost for more people.
- c. Advisor Joseph - who's teaching the course? Isaac - people in the EMT area.
- d. Sen Kshitij - what's the time and place? Isaac - the date might be pushed back in a week or 2, but it was originally scheduled for next week. He will let everyone know during the next club report.
- e. Advisor Joseph - will the participants be chosen by sign-ups? Isaac - yes, they'll use sign-ups
- f. Treasurer Michael motioned to approve the budget request of \$240 for the Pre-Med Club. Seconded by Sen Kshitij.
- g. Secretary Anchal conducted a roll call vote, and the motion was passed by majority vote.

B. SSSCC Alternate Delegate Election | 10 minutes

- a. Advisor Joseph - since Sen Bridget has transferred, Treasurer Michael has taken over as our primary SSSCC delegate, and he needs an alternate. Asked Treasurer Michael how much the monthly time commitment is. Treasurer Michael responded that it takes 3-5 hours. The meetings are available on zoom but it's also recommended to join in person to interact with the others. Joseph - it's a great chance to interact with delegates from other ASG groups.
- b. Dean Barnard - explained what the SSSCC is. The SSSCC represents all of the 117 community colleges, which are broken down into regions. Each region has a body like ours, and the SSSCC represents all of them at the state level. The state meeting, once a year, is where you vote on resolutions. They essentially advocate for all the community colleges.
- c. Advisor Joseph - would anyone like to self-nominate or nominate someone else? Sen Kshitij self-nominated himself.
- d. President Ariella asked for clarification on who can be nominated. Joseph responded that only senators can be nominated.
- e. Advisor Joseph conducted a hand vote, and since Sen Kshitij ran uncontested and the majority raised their hands, he was voted in as the new SSSCC alternate delegate.
