<u>Update on types of research data to be included in full Program Review for the 2018-2021 Cycle.</u> Xi Zhang stated that the research office has reviewed the draft template from the committee and had some questions/items that needed clarification. How do we want to define program and evaluate it? The degrees and certificates and the required courses for that program was what the committee agreed was warranted to be looked at for the effectiveness of a program. Zhang mentioned that committee wanted program level degrees and certificates which was no problem for her office. However, transfer level data disaggregation was something that cannot be produced. It was decided that Zhang will bring a draft of a program review to bring to the committee to promote some discussion before she goes fully into the whole program review for the 2018-2021 cycle.
