1)	Program Review Update
	Barnard shared the 2019 Fall Student Services Personnel requests from each department.

	meeting. The importance of completing this task is in the event funds become available, needs
	have been identified, reviewed and ranked.
2)	BRDS Reminder
	Gonzales reminded committee if interested in submitting request for supplies and classroom equipment/ technology to BRDS the deadline is October 16, 2019. Identified needs should be linked to Program Review. Teresh posed the question regarding where a request for additional tents and tables can be submitted, as it is a campus wide need. Gonzales recommended to initially submitting the request to BRDS. Secondly, to Facilities Committee. Gonzales mentioned recent conversations regarding playing music for campus wide events and a possible need to identify where to initiate the process for a membership program. Additionally, pointing out regulations regarding Student Travel, if the College does not sponsor event, students are required to fill out a waiver form. For additional assistance can contact District Rick Management Office, recommended to discuss with Deans or Vice Presidents.
