- 5) Course proposals
  - a) New courses
    - i) EXSC 144B Fitness Walking II Includes DE proposal
    - ii) EXSC 144C Fitness Walking III Includes DE proposal
    - iii) EXSC 144D Fitness Walking IV Includes DE proposal
  - b) Activations
    - i) EXSC 144A Fitness Walking I Includes DE proposal
      - (1) M. Cain stated EXSC 144A is currently being offered at City and Mesa College. Miramar is requesting to activate this course in addition to proposing the new EXSC 144B, C and D. They are variable unit courses ranging from 0.5 to 1.0 units. The Exercise Science department would like to target students whom do not have access to a weight room or cannot physically attend class. The students will be required to use a tracking device or a free application to monitor and improve their aerobic capability.

  - (2) The committee discussed the courses' impacts when applying for the Economic Development Corporation grants.
  - (3) Motion to approve CISC 181 and CISC 192 by I. Feldman; seconded by J. Alva; motion carried.
- iv) <u>HUMA 101 Introduction to the Humanities I</u> (Mesa originating) Six-year review and updates to example texts.
  - (1) M. Sanft stated Miramar's Humanities department approves of the proposal.
  - (2) Motion to approve by J. Alva; seconded by I. Feldman; motion carried.
- v) <u>PERG 120 College Success and Lifelong Learning</u> (Mesa originating) Six-year review and removal of supplies since they are zero-cost.
  - (1) M. Sanft stated Miramar's Personal Growth department approves of the proposal and suggests adding an additional textbook. D. Short forwarded the suggestion to Mesa's Curriculum Chair.
  - (2) Motion to approve with the understanding that the aforementioned suggestion had been forwarded to Mesa; seconded by J. Alva; motion carried.

  - i) <u>Law Enforcement Technologies CA</u> Revision to accommodate change in law enforcement academy to single course ADJU 260 and addition of restricted elective options. (Held from last meeting; District office confirmed that at least two courses are required.)
    - (1) M. Sanft stated D. Short confirmed with the District Office that at least two courses are required for a Certificate of Achievement per the State Chancellor's Office.
    - (2) The committee discussed the following points:
      - (a) The possibility of adding language about the three-course residency requirement within the District for earning a Certificate of Achievement in the catalog
      - (b) Keeping the Student-Centered Funding Formula and residency requirement in mind when creating and editing awards
    - (3) Motion to approve with the recommendation to add language about the three-course residency requirement within the District for earning a Certificate of Achievement in the catalog by R. Zimmerman; seconded by I. Feldman; motion carried.

### 7) Other business

- a) Courses to meet new CSU GE Area F (ethnic studies) requirement
  - M. Sanft stated the CSU system has proposed a new GE Area F (Ethnic Studies) requirement. It will go to the CSU's Board of Trustees for review and ratification. The District's transfer students will also need to complete this requirement. Miramar will need to propose courses

that meet Area F during the yearly CSU GE/IGETC articulation cycle. This year's review for Area F has been extended to February 2021.

- ii) Based on the definitions and the core competencies listed by the CSUs, the courses need to cover four racialized groups in the U.S. (African American, Latinx, Native American, and Asian studies). Miramar offers limited options compared to City and Mesa.
- iii) The committee discussed the following points:
  - (1) The development of the ethnic studies degree
  - (2) The curriculum timeline process for Miramar to activate City and Mesa's ethnic studies courses or revive deactivated courses, and the possibility of fast tracking the process
  - (3) CSUs' narrow acceptance of courses within specific prefixes (i.e., subject areas)
  - (4) Possibility of changing existing courses to another subject area [e.g., FILI (Filipino Studies] to ASIA (Asian Studies)], exploring Latinx and Chicano Studies, and proposing to create a new subject area [e.g., AMIN (Native American/American Indian Studies)]
- iv) The committee agreed to the proposal of creating an Asian Studies and Native American Studies subject areas. M. Sanft will forward the request to the Curriculum Instructional Council.
- b) Multicultural course graduation requirement update
  - M. Sanft stated there is currently no update since the District Office and District Articulation Council are waiting for more updates in regards to changes in Title 5 or other state legislation from the CSU system and the State Chancellor's Office
- c) Culturally responsive content in curriculum
  - i) M. Sanft stated Laura Murphy requested D. Short present to the Academic Senate on what the Curriculum Technical Review Subcommittee wishes to do in regards to reviewing for culturally responsive curriculum design. He provided an overview of the plan, but had been given a short time frame to present. The Academic Senate had further questions and concerns about the matter. Therefore, D. Short, Alex Mata, and M. Sanft drafted two documents which outline an explanation of what the subcommittee would like to do (suggestions about culturally responsive curriculum design – not approval/disapproval authority, Diversity/International Education Committee input/expert, testing, request for a formal change to the College Governance Handbook) in addition to the Academic Senate for California Community Colleges' Call to Action/Resolution and curriculum process. M. Sanft showed the documents to the committee. Overall, the documents had been well received by the Academic Senate.
