The committee and the curriculum presenter (John Couture) held a lengthy discussion about the necessity of this course. Concern was expressed by several committee members that the course did not meet the criteria of appropriateness to the college mission as is not required in any of the current degree programs nor did it meet transfer requirements for computer science degrees, nor did it lead to employment. The proposed course did not appear to meet the criteria of need and/or demand; the presenter was unable to provide information as to why students would take this course, if there was an industry demand for the course content, or to explain why the course was needed at Miramar. The presenter informed the committee that he didn't care if the course was approved, and that he only created the course to meet his contractual requirements. Further, the question of feasibility was raised and whether, with reduced funding, this course could be offered at least once every two years. The committee concluded that the proposed course did not meet the necessary criteria for approval.
