- Parking Task Force has not formally met. L. Bosselman asked about the low emissions parking spaces at Aviation as well as the increased areas for handicapped, the two quick pickups at Repro, and motorcycle parking, resulting in a net loss in spaces. Concern was voiced with enforcement as well as other issues
 - such as who mandated, and what is definition of low emissions. B. Bell stated it was part of the architect's package to apply for LEED certification to get from LEED Silver to LEED Gold. It is not a District mandate. Question was asked if the area between A-100 and F-100 will go away when doing infrastructure a few years out. Parking structure to be built close by with promenade walkway to be built. B. Bell stated he has been mindful of need for staff parking and trying to keep a balance. Enforcement policy needs to be addressed and definition of what a low emission vehicle is. D. Gutowski suggested putting the stalls on east side of A-100. Sgt. Diane Madero will report back at next facilities meeting on the code enforcement policy, definition of low emissions, and request to look at staff parking in lot 2.

1) Hillery Entrance Improvements

A new additional entrance to the campus is planned, it will be off of Westview Parkway. Caltrans is extending the road which will create a traffic route to the parking structure and the bus drop off area. Behind/west of the new Administration building will be a walkway out from the Admin office to the vernal pools. Connection from the LLRC patio area creating two outdoor areas, one concrete and on one informal area of decomposed granite. Campus events can be held in these areas. Concern was expressed by committee members if there would be paved access for foot traffic, whether the project will link to parking structure 3, and concern about the traffic from buses with regard to student foot traffic. J. Bray said he would look at the function of the light at Mesa and if that is an option to address these concern at Miramar.

- J. Bray stated the design process has begun for improving the Black Mountain entrance. The design will take the hump out of the road and widen the exit, the sidewalks will be picked up on both sides and eliminate the retaining wall to create a better transition into the campus. L. Bosselman asked what the timeframe is. J. Bray said he is looking into when they can do the work since the main entrance will need to be shut down.
