There is no end date to the partnership agreement, however the agreement can be voided with a 30-day notice without cause by San Diego Miramar College, the Miramar College Foundation, or California Coast Credit Union.

As a partner with San Diego Miramar College and the Miramar College Foundation, California Coast Credit Union is pleased to offer the following benefits to the students, faculty and staff of San Diego Miramar College. We propose the following communication channels at San Diego Miramar College to inform students, staff and faculty of the special offers and advantages available as a member of California Coast Credit Union.

## Benefits provided by California Coast Credit Union to students, faculty and staff:

- \$25 deposited to qualifying new member accounts and \$25 donated to the Miramar College
  Foundation through our Cash 4 Schools program.
- Special offers and discounts available to students, staff and faculty at San Diego Miramar College through our Preferred Partner program. These offers and benefits are not provided to the general public.
- Personal banking service provided monthly on campus (by arrangement) during the school year.
- Access to no-cost financial workshops offered on campus (by arrangement) or at California Coast's offices.
- Membership fee waived for all students, staff and faculty at San Diego Miramar College.
- Support of events at San Diego Miramar College such as Foundation fundraisers, and special cause events.
- California Coast is open to occasionally posting college major events on its public website.
- San Diego Miramar College will provide a location on campus for financial guidance and counseling by credit union professionals if a request and schedule are provided at least 30 days in advance. The room will be posted "Financial Education and Guidance," provided by California Coast Credit Union, an approved Miramar College Foundation community partner.
- Communication Channels provided by San Diego Miramar College to inform students, staff and faculty of the benefits offered by California Coast:
- Mentions included periodically in eNews and other San Diego Miramar College announcements about Cal Coast and that representatives will be on campus to assist students, faculty and staff.
