## FELONY/ DRUG/ MISDEMEANOR DISCLAIMER

### BACKGROUND:

State law (Penal Code 12021) prohibits a person who has been convicted of a felony under the laws of the United States, State of California, or any other state, government, or country, or any person who is addicted to the use of any narcotic drug, from owning, possessing, or having under their control or custody, any firearm. Section 12021(c) (1) prohibits any person convicted of any of the following violations from owning, possessing, or having under their custody or control any firearms within 10 years of the conviction. Federal law prohibits anyone convicted of any misdemeanor under any federal or state law which has as an element an act of "domestic violence," as that term is defined in Title 18 U.S.C. 921 (a) (33), from ever owning or possessing a firearm (18 U.S.C. 922 (g) (9)).

Federal law further prohibits anyone who is subject to a court order relating to domestic violence as defined in the section where the order includes a finding that the person represents a credible threat to another, or which explicitly prohibits the use of force or threatened force against another, from owning or possessing a firearm (18 U.S.C. 922 (g) (8)).

State law prohibits anyone who is subject to a protective order as defined in Family Code 6218, or a temporary restraining order or injunction issued pursuant to Code of Civil Procedure 527.6 or 527.8, from purchasing or receiving a firearm (P.C. 12021 (g)).

State law further prohibits anyone who is subject to a protective order per Family Code 6218 where the court has made a finding that the subject is likely to use or display or threaten to use a firearm in any act of violence, from owning or possessing a firearm (Fam. Code 6389).

This course includes firearm instruction and the actual handling and firing of firearms by students. Individuals having a felony conviction, or who are addicted to the use of any narcotic drug, or specified misdemeanor convictions within the past ten years, or any misdemeanor conviction for domestic violence, may not legally own, possess, or have under their control or custody any firearm.

Successful completion of this course includes the completion of firearms instruction. A student could not legally participate in the instructional phases involving firearms, and would not be eligible for course certification.

The San Diego Regional Public Safety Training Institute and its staff will not knowingly contribute to a violation of Federal or State laws.
